- Permission to reproduce the supplied image material is dependent upon the full acceptance of the Terms & Conditions listed herein and will be automatically revoked if any part is infringed.
- 2. Where the Applicant seeks to reproduce copyrighted works, the Gallery will notify the Applicant of the copyright holder's contact details, if known. It is the Applicant's responsibility to obtain <u>written permission from the copyright holder</u> and to provide a copy of such permission to the Gallery. The Applicant is responsible for any fees that the copyright holder may impose, separate and distinct from any fees charged by the Gallery.
- 3. Images are <u>not</u> to be cropped, overprinted or altered in any way without prior written approval from the Gallery. Requests for such alterations, or for the use of images on book covers and commercial merchandise, will only be considered upon receipt of a realistic mock-up.
- 4. All fees stipulated by the Gallery for the supply and use of images must be paid in full before image material will be dispatched to the Applicant.
- 5. Each reproduction of an image is to be accompanied by a <u>caption</u> supplied by the Gallery. It is the Applicant's responsibility to acknowledge artistic works in accordance with Australia's Moral Rights legislation.
- 6. The Gallery reserves the right to refuse to supply image material or to revoke reproduction rights where the context or quality of the reproduction is deemed to be unsuitable, inappropriate or contrary to the artist's or the Gallery's interests.
- 7. All physical items that may be supplied (CDs, DVDs, transparencies, match prints) are <u>loaned</u> for a period of <u>six months only</u> from the date of dispatch and must be returned in good condition. Requests for extensions must be received in writing prior to the expiry of the loan period. The Applicant is liable for the full replacement cost if image material is lost or damaged.
- 8. Prior to publication, a hard copy colour printer's proof of each image must be sent to the Gallery, along with the Gallery's match print (if supplied), for colour-checking and approval. The Gallery will endeavour to approve the Applicant's proofs within 24 hours of receipt.
- 9. One complimentary copy of the publication or product must be sent to the Rights & Permissions Officer immediately upon publication.
- 10. Reproduction rights are non-exclusive, for one time use only, and may not be assigned, transferred or sub-let to any other party.

AUSTRALIAN ORDERS

Delivery times

NEW PHOTOGRAPHY

New photography requires up to 12 weeks to complete.

EXISTING IMAGE MATERIAL

Images produced from existing image material require up to 4 weeks to complete.

DEADLINES

Due to variable circumstances, heavy workloads and schedules, the Gallery cannot warrant that the delivery of image material will meet your deadline if the lead time is less than 12 weeks for new photography or less than 4 weeks for images produced from existing image material.
