The probable cause of the arrest of the above-named individual is as follows:
 [On 4-25-19 at approximately 1015 hours Mr Santi Leon Martinez 4-30-70
 (Identified by employees and Colo DL information) was working as an employee at
 the Goodwill Store at 21 S Broadway which is in the City and County of Denver.
 He confronted [REDACTED]
 [REDACTED] on the south side of the building and an argument started. Mr
 Martinez was punched in the face and possibly maced by [REDACTED] Mr Martinez
 then pulled out a knife and cut [REDACTED] [REDACTED] ran into the Goodwill
 Store being chased by Mr Martinez. Inside the store [REDACTED] continued being
 chased by Mr Martinez until they got to the back of the store where Mr Martinez
 cut [REDACTED] one more time. [REDACTED] fell to the floor and Mr Martinez walked out
 the front of the store. Mr Martinez was stopped by officers at W Archer Pl and
 S Broadway St still in possession of the knife. He was taken into custody
 without incident and transported to Denver Health by ambulance for facial
 injuries and mace.]
