# **Tenants Resist Eviction**

THE SOUTH SIDE of Jasmine Terrace, in St. Clements ward, Aberdeen, consists of a long, crumbling row of three-storey tenements which are possibly the worst slum houses in the city. The houses, some of which are owned by private landlords, and some of which the Town Council has bought over, have been condemned for several monthsbut the tenants were originally told not to expect alternative accommodation until next January. This would obviously give them time to see different houses and be rehoused according to their respective wishes and needs-there was even some talk, according to one tenant, of rehousing the entire side of the street in a new multi-storey block which is nearing completion nearby. However towards the end of July the stonework surrounding a second floor window in one of the houses crashed into the street below. No one was hurt, but the Council now decided to step in and rehouse the tenants immediately. As usual with the bureaucracy, this was done with a combination of haste, heartlessness and conceit which provoked an inevitable resentment and resistance

INITIAL RESISTANCE

By Monday, July 29, eight families— a total of 25 people—had taken the lead and said that they would not move. That evening two Aberdeen anarchists went down to the street to find out what the real grievances were, and to offer any help we could to the tenants. We found people outside in the street, knots of people discussing, arguing, questioningwhat would the Council do, what could they do. Others leant out of their windows and joined in conversation with their neighbours, one sang a line of 'We shall not be moved' and laughed,

What were their grievances? Firstly people were annoyed by the haste with which the Council acted. Certain families were served with 'phase one' vacation orders giving them only three days to quit the condemned properties, others were given nine days. However, from the half-dozen or so tenants we spoke to, it was apparent that there were many other reasons. Firstly some of the houses offered to them by the Council were damaged, with such problems as damp and rotten fittings. Surely after living in conditions such as they have been, they are entitled to decent, good

Further, there were health issues involved, and the almost blatant cruelty of the Council to some of the tenants on this issue is incredible. One man, an arthritic, works only two minutes away from Jasmine Terrace. He was offered a house FOUR MILES away, at a higher rent (soon to rise again); if he took this house he would have to abandon his job, and consequently could not afford the new house. 'He wants to work,' said his wife, 'but if we moved there he just couldn't. I've been at my wits' end since we were told to move.' Another person, semi-cripple, was offered a high flat. A woman who asked for somewhere central, was given the top flat in a multistorey on the uttermost edges of the city!

Some people were also worried about the areas they were being sent to-areas where the Council ghettoes off those considered to be social nuisances in whole streets. Most of the houses offered were there and the people, especially those with children, thought they should have been offered a better choice of accommo-

The tenants were undoubtedly angry and resentful, but confused as to what the Council could do-a few expressed disbelief that they could be compulsorily evicted—and confused as to what they themselves should do. Their friendly response to our questions gave us some encouragement, and we decided that since we couldn't go round to everybody advising them to resist, we would duplicate and distribute a leaflet that night, to all the tenants. It was already nearly 9 o'clock when we left the Terrace, and after 10 when we came back with our leaflets. These advised that the tenants should all resist eviction until everybody was decently housed, and offered to help them if the Council attempted a physical

The houses seemed to be bad when seen from the front where we had spoken to people in the street. To distribute leaflets it was also necessary to go through a close to stairs round the back of the houses. Worn wooden stairs, which shook as you stepped up them led to the second floor. The rooms themselves could not have been more than 7 ft. high, since there were three storeys in a building about 25 ft. high—in some cases there were even four storeys, a labyrinthian basement which was 1 under-

## **POLICE MOVE AGAINST** BERTARIAN' PUB

THE INTEREST TAKEN by the police in the social life of political activists has again manifested itself in an attack on a certain group of people in the Hornsey area. Under the blanket term 'Anarchist', militants have been provoked and attacked by the police using dogs, outside the Queen's Head Public House in Hornsey. Six people were arrested by the police after leaving the pub on Friday, July 19-significantly two days before the demonstration against the American Embassy.

The pattern is emerging that wherever political activity is at a high level, the police move in and victimise the militants. This has happened both in Hornsey and in Notting Hill Gate where Anarchists, members of the Vietnam Solidarity Campaign and International Socialist groups are much in evidence. It would appear that although publicly the Home Secretary is reluctant to ban

political demonstrations, the police are being exhorted to intimidate militants at a local level in order to effectively reduce their numbers on such demonstrations.

In the Hornsey affair the official reason given for the presence of about thirty policemen and their dogs (it is becoming increasingly difficult to differentiate the two) outside a peaceful and well-run public house was that there was a lack of managerial supervision. The brewers would seem to disagree with this particular analysis as the present management remains, and the three people who were bitten by police dogs and the six who were arrested would tend to agree that the pub is more humanely supervised than the nearby streets.

Money is urgently needed to fight the case and any contributions would be gratefully received.

# Thank you, Papa!

SELF-DESTRUCTIVE dogmatism in an opponent is always a most acceptable free bonus in any struggle especially with a cunning and experienced enemy.

Revolutionists all over the world, who recognise the Catholic Church as one of the greatest obstacles to human emancipation from fear and exploitation, must surely see the Pope's encyclical on birth control as a most welcome error of judgement on his part that can have disastrous results for his own organisation. The monolithic structure of the Church of Rome is taking a knock from which it may never recover, and the speed and strength of the reaction against the old fool's pronunciamento from his own followers is unprecedented.

It clearly took him by surprise, for never before has a Pope felt constrained to make public appearances to justify policy statementsand Pope Paul did so twice within a week! And when we consider that he has been reflecting on this 'problem' for four years (at least). suffering, he assures us, no little spiritual anguish, then we can only be confirmed in our belief that a celibate septuagenarian with his head stuffed with nonsense who has passed his years (we cannot say 'lived his life') in the rarefied atmosphere of the Vatican is so out of touch with real life that it is nothing short of bloody impertinence for him to pronounce on anything.

So he suffered—what? On the cruel horns of a dilemma of his own making, he had to decide whether the suffering involved in the unwilling procreation of the past had been in vain-or to condemn Catholics to the same unnecessary suffering in the future. He chose the latter.

Rather than admit that the Church

has been wrong over the years, His Holiness has chosen to maintain a cruel teaching which millions of his own followers have already rejected. It is a desperate attempt to re-establish an authority which is already slipping away; it is an attempt doomed to failure.

Being celibate (presumably) by choice Il Papa can know neither the ecstasy of a happy sexual union, nor the black despair of a frustrated one. Glibly he gives his blessing to the unreliable 'rhythm' or 'safe period' method of avoiding conception, assuming in his ignorance that you can make love by the calendar!

Does he travel by donkey like Jesus or does he fly by jet to his international assignations? Does he object to farmers growing ten ears of corn where God provided only one? Does he dress in bear skins or cloth of gold?

## THE LION VERSUS THE UNICORN

owner and manager of the Unicorn Bookshop, at 50 Gloucester Road, Brighton, 1, Sussex, is prepared to appear before the Brighton magistrates to face charges of offering for sale various books and periodicals of an obscene nature. It is a bitter and savage affair for those involved for one must believe, rightly or wrongly, that too many worthy members of the Brighton Establishment are taking part in a particularly nasty type of witch hunt as a sop to their own feelings of alienation from that vocal minority who, with spoken and written word, hold the Establishment and its bruised beliefs up to public ridicule.

If this is so, and I believe it to be, then the Brighton bourgeoisie are as one with the street corner yobs persecuting an inoffensive youth for carrying a book through a slum street. To walk through the twisting back streets of this prosperous sea resort, to turn one's back on the broad, flower-patterned boulevards, and the wedding-cake white Edwardian imperial hotels for the Bed and Breakfast rows of back-to-back working-class houses, to leave behind one in a matter of minutes the smart and expensive restaurants for the egg and chips cafés, is to accept that Brighton must grudgingly and reluctantly acknowledge that her working-class ghetto is a permanent irritating ulcer within the body of this sun-tanned corpse and it must follow that the Establishment will view with alarm any manifestations of a revolutionary culture, be it a protest against a distant war or the public reading of a poem that has as yet not been officially embalmed within some conservative anthology.

The comic postcards are there for the London proletariat to send to their GLC friends, and the boarding house strangers sleeping on the shingle beach will be tolerated within the hours of daylight. but when the Brighton Establishment have prayed into their cheque books and climbed into bed with their fraus, they do so in the pure knowledge that their police are then prowling the streets to hunt down any mad dog daring to read a poem in public, sleep on their beach or sell a non-commercial literary magazine that contains the word 'fuck'.

The Unicorn Bookshop is a tiny two-roomed corner shop in an area of seedy decay. Its shelves were once crowded with the posters, the duplicated sheaves of poetry, the avantgarde literary magazines, and all the ephemeral fermentation of minds eager to communicate answers and questions to the problems of the hour, and it is to the credit of Bill Butler that he has won an international reputation for this small backstreet bookshop in that

ON AUGUST 20 Bill Butler, the it is a place that can offer the people living within Brighton and its surrounding areas access to the living cultures of Britain and the Americas. It is a large claim, but the proof lay on the packed and untidy shelves and with the feet of the intinerate poets and writers who made this small shop a necessary halt on their sad and endless journey.

When the police left the Unicorn Bookshop they confiscated almost all of Butler's stock and even now he is fighting to regain the £700 worth of stock that he might be able to avert bankruptcy, but at the time of my visit he had been unsuccessful.

It is rumoured that the Authorities are examining Oz, International Times, Kulture, Evergreen Review and Cuddon's Review No. 11 before they decide on which one they shall base their case, and rumour holds, and there is no other source of information for those who sympathise with the defence, that Cuddon's Review No. 11 might form the basis for the Prosecution's case against Bill Butler and Unicorn Bookshop. Cuddon's Review No. 11 was nothing more than a straightforward reprint of FUCKNAM, written and published in New York by Tui Kupferburg. It has been on sale within the London area for more months than I could care to remember, for one became so tired of moving it aside to inspect fresher imports from the States. It was never deemed to have any great literary merit for its importance was that while his country was engaged in a futile and obscene war, an American poet wrote and had published his protest against his Government's actions and one must surely ask those stupid people who form the Brighton Establishment how they will justify their support of their police's action when the American Government, who is the one who is attacked, can tolerate FUCKNAM.

The answer is unfortunately only too obvious, for any non-conformist within these suburban swamplands of the status quo must, by the very act of nonconforming, attract other like-minded people, no matter how simple or innocent his non-conformity. For that reason, with history as our witness, the Brighton Establishment are waiting for the death kill with the Unicorn as its prey. Bill Butler has reason to feel bitter, for he has been denied free legal aid, his book stock has been confiscated, the national press, with the exception of the Standard and the Guardian, have shown a complete lack of interest, and, with but one or two exceptions, all the major publishers have chosen to ignore Butler's appeal for financial help.

But remember this. That if the

Brighton Authorities decide to prosecute Butler on August 20 for selling Cuddon's Review, it actively concerns you as anarchists, for during its active life Cuddon's was an important forum of anarchist discussion. So of your small wealth send your token mite to Bill Butler at his Unicorn Bookshop, and mark it 'from a reader of FREEDOM' and let it be your gesture for aid to another man's battle.

Let me give the last words to that keeper of the conscience of the Establishment of the Left and the Right, Peter Simple II who, speaking through the mouth of his Mr. Justice Tulmult, stated that 'the book in question' as 'an emetic, by its nature, must purge rather than poison the system. He (the defendant) did not, I am glad to say, resort to the absurd defence provided by the Obscene Publications Act of 1959, that a work of pornography becomes harmless if it shows literary merit, as though a well-made bomb were less harmful than a badly made bomb'.

# **WOULD YOU LET THIS MAN**

last night that it is taking strong action against the pseudo-religious cult of codology. Its schools will no longer be recognized as educational establishments and students of the cult will no longer be recognized as serious students.

The Minister of Health said, 'It alienates husbands and wives and attributes squalid and disgraceful motives to all who oppose it; its authoritarian principles and practice are a potential menace to the personality and well-being of those so deluded as to become its followers; above all its methods can be a serious danger to the health of those who submit to them.' I understand he refers to the bizarre sexual practices to which followers of the cult are now pledged and incidentally to the dangerous practice of compulsive chastity carried on by its acolytes. The Minister was not of course referring to the peculiar sexual history of the movement's alleged founder.

The Minister added that there was evidence that children were now being indoctrinated by the cult. I understand that this has been happening for many years, indeed it seems to be an article of faith with them that children of parents practising codology must be reared in the cult, even if only one parent should happen to be a practitioner. The most dire pains and penalties attach to any parent who disobeys.

The Government has acted after a number of complaints about the practices of the movement, which has its headquarters in Italy, presumably to avoid income tax.

I can reveal that this is not the first time that complaints have been made and action has been taken against the organization. An important commission of inquiry's finding were that the Montini ('papa' Montini is the head of the organization) Association of Codologists claims to be the world's largest religious cult. What it really is, however, is the

THE GOVERNMENT ANNOUNCED world's largest organization of people, unqualified in either sex or sin, engaged in the practice and explication of both, the former by means of a dangerous technique which masquerades as scientific birth control. The report also said, 'Codology is evil; its techniques evil; its practice a serious threat to the community, medically, morally, and socially; and its adherents sadly deluded and often mentally ill.'

The founder was said to be a beatnik writer of fantasy-fiction who associated with a dissolute gang and came to a bad end. It is claimed that codology, as its name implies, was given form by a fisherman Peter. The cult made the further claim recently upon the flimsiest of evidence that Peter's bones had been discovered in Rome.

Among the claims made by the cult are spontaneous creation, the salvation of mankind, and preservation of all species from a disastrous flood, sundry miracles, feats of healing, one resurrection from the dead, dividing a sea, stopping the sun's rotation and other unlikelihoods which they take as 'Gospel

It is time that this cult was stopped and, now that 'Papa' Paul has come out into the open and dictates how husband and wife should behave towards each other, it is time that the British public asked itself, 'Would You Let This Man Creep Into Your Bed?' We know what the answer will be.

THE MAY DAY COMMITTEE'S leaflet on the busmen's pound (re-printed elsewhere in this issue) is quite right when it says: 'Let the people once resolve to defy the law and the law is finished.' Yet, except for a few minor skirmishes, no substantial number of trade unionists have broken through the Government's incomes policies. The examples where they have, have been when workers have taken action as in the case of the Ford women machinists and the Liverpool busmen. But in both these cases, the real substance of the legislation was not challenged.

these cases, the real substance of the legislation was not challenged.

The Municipal busmen's pound is a classical example of the type of agreement the Government's legislation was enacted to prevent. Obviously the Government has chosen the ground well any which to make a strend. The fact that on which to make a stand. The fact that the Municipal busmen receive very wages, a thing the Prices and Inco wages, a thing the Prices and Incomes Policy was supposed to remedy, will not inhibit Mr. Wilson and his Cabinet. The impact of the proposed strike will be negligible on the economy and so it is essential that other workers see this struggle as their own.

Already the General and Municipal Workers' Union's executive have opted out of the battle, but if their members amongst Liverpool's busmen are anything to go by, I cannot see many of

thing to go by, I cannot see many of them scabbing on their brothers in the Transport and General Workers' Union. At the same time, Mr. Cousins of the

T&GWU does not really favour a full strike. It is still on the cards that a deal will be worked out. Agreements on will be worked out. Agreements on back-dating next December and produc-tivity deals similar to the London bus-men's are being talked about. Whether the strike is called off remains to be seen. but if it does take place, busmen will need all the assistance they can get. I do not expect any advocacy by union

officials of the 'free rides' tactic, but it still remains, in my opinion, the best

ENGINEERING STRIKE?

ENGINEERING STRIKE?

While a bus strike would not hit the economy, a strike by engineering workers would harm it and the balance of payments. Another breakdown in the negotiations brings us, in theory, closer to just such a strike. The unions are claiming an outright increase with no productivity strings. The employers are following the Government's policies and the most they are prepared to offer is 9% over three years, dependent on the removal of restrictions on trained men removal of restrictions on trained men and the laying down of productivity guide-lines which would include work measurement

There is only one way to defeat the Government's policies and that is by industrial action. Employers now hide behind the Government. All sorts of delaying tactics are used, procedures are drawn out, while all the time the employers are making record profits. While profits are reaching new heights,

employers, thanks to the Government's anti-working class policies, are flexing their muscles. They know that they have the Government's backing for any rationalisation plans. Sun Engraving are doing just this. From August 15, they are sacking 350 workers at their Holborn works in London. For a number of years, this plant has not been very profitable, but it is only now, with increasing unemployment, that they are making these men redundant. Threats of dismissal by the Newspaper Publishing Association and sackings by the new ITV companies should be seen as a toughen-ing attitude by the employers. Publishing

ing attitude by the employers.

In this sort of atmosphere there is no place for a soft approach. The Labour Government is putting over the biggest swindle going and by and large they are getting away with it. It only needs defiance to beat these policies and the determination to take action against something which is wrong. Once this challenge is taken up by the workers, there is nothing the Government could do. The last thing the State wants to do do. The last thing the Government could do. The last thing the State wants to do is to gaol trade unionists, because once that happens, the whole dispute will spread. The State could not gaol the dockers just after the war or the gas workers in the fifties. It could not do it today and, as in the past, the law, because of once dockers, and the law, because of once dockers. because of open defiance, would be made to look the ass it is.

tion dealing with the day-by-day activi-ties of the Communist Party and CGT, with glances at the Trotskyists, Maoists and others, whose attitude was essentially the same. All these authoritarian groups seemed to be more interested in trying to bridle and tame the movement, and

The problem still remains, why is it that people feel the need for some authority to turn to, even in a spontaneous uprising such as this. Not all feel the need, but very many evidently do. Usually there are enough of them who feel it to drag down the others, and finally bring everything to a halt. It is

who feel it to drag down the others, and finally bring everything to a halt. It is not much help to pin down the manoeuvres of Stalinists, Maoists or Trotskyists—well, it has a certain clinical interest and value—but the fundamental question is not answered. If there were no Stalinists, Maoists or Trotskyists presumably there would be other groups who would act in the same way. This account only covers two weeks.

From an anarchist's point of view, a school should be a gathering of children, of all ages and sexes, who are looking for and given instruction in any aspect of living and learning, where prolonged and repetitive training is lovingly given to the seeker.

Progressive education has of course always played a great role in anarchistic thought. Clearly the necessity of explaining a way of life—often against an hostile society—to live a courageous exemplary life in which one expresses the quintessence of one's basic philosophy, is fundamental for the propagation of this philosophy.

The number of great school-men in this field are small and it is only Homer Lane, A. S. Neill, Paul Goodman and Michael Duane who are front-tranking and courageous figureheads in the formulation and realisation of schools which fulfil mentanction in the above definition.

which fulfil therestanction in the above definition.

Michael Duane built up Risinghill School and made it a byword for progressivity and lovingness. He enforced the abolition of the cane. He enforced the equality of child and teacher, an absolute must, if an equalitarian society ever becomes a reality. I quote here from an unpublished paper of mine: The Emancipation of the Child: The equality of the child in our society is a basic liberty and essential for a normalisation of our life. The acceptance of the child as an individual with its full, uninterfered rights to its demands, is axiomatic for a free vidual with its full, uninterfered fights to its demands, is axiomatic for a free and healthy society. Needless to say that the battle between the authorities, in this case the LCC and Duane, grew

in this case the LCC and Duane, grew to such an extent that ultimately the school was closed in 1965.

However there is a fascinating further aspect to this. When I came across a review of the book in a brotherly organ like Peace News, a man called Keith Pople indulged in what can only be described in American terms as a smear campaign. He felt he was nearly fooled by this book. He quotes the liberal drug dreamer, Aldous Huxley, for the most meaningless quote of the century, and finally makes it clear that teachers and children are different people, and that teacher is always right, no doubt.

Mr. Pople's review would do very well for an establishment paper, where the return of the cane would be connived, where the inequality of child and teacher would be clearly accepted. What on earth is Mr. Pople doing in Peace News?

What on earth is Mr. Pople doing in Peace News?

The most frightening aspect of a man like Mr. Pople, to appear in a paper like Peace News, seems the total disregard for the basic theme of Leila Berg's book, the need for 'destructuring'. Although I know this is a horrible word, I cannot find a better one at the moment to describe what we all feel to be the demand of the hour, to break into the cold, callous, heartless, ruthless, often pointless, machine of the establishment, which never ceases to engulf the individual in our society, from the moment of its birth to its death. The structure of patriarchal society, with its absolute and preposterous values, is at this very moment under fire from the youth from Peking to New York.

Clearly, one of the many causes of war is the unthinking continuing preservation and prolongation of, for instance, militaristic machines, which still eat up a vast proportion of everybody's national income. We all know it to

who would act in the same way.

This account only covers two weeks, and does not deal with the period of decline, which would be the most interesting part of the story. If we are to learn from the past how to cope with the future, if we are to learn how not to let this happen again, this is the period we need to know about most of all.

Ironically, just before France exploded, I wrote in FREEDOM about the failure of revolutions in the past. I hoped I was going to be proved wrong by events. I am hoping still that I may be. That the present calm may merely precede a second and more successful rising. Meanwhile we must do all we can in England to help the French students and workers, some of whom have taken refuge among us.

# Participation?

WORKERS' CONTROL means the ownership and control of the means of production in the hands of the workers themselves for the mutual benefit of everyone.

The Labour Party always sidesteps this issue because it is violently opposed to control from the base. Nationalisation was a sop to the pioneers of the Labour movement who believed in workers' control.

The new gimmick for the Labour Party is industrial democracy workers' participation. According to their latest publication, 'provided workers are supplied with the knowledge of directors fees, labour costs, investment data, and profits, etc.', then industrial relations can be

classed as well on the way to being settled for ever. What the Labour Party forget to remember is the fact that workers' participation means assisting in the running of industry primarily in the employers' interest and by so doing, if the workers gain a little, no great harm is done. Management not only reserve the right to manage but insist.

In the last twenty years many words have been aborted—socialism, communism and now the words workers' control' are going through this process, anything to detract from the basic and original meaning.

Workers' participation is a sound industrial policy for the corporate state. Workers' representatives can be allowed to make decisions on practically any issue, except upon the only one that matters-the decision to own and control.

Throughout industry there are many 'gimmicky' workers-management committees whose real value is debatable. The only value perhaps is that through such committees the workers' job can be made much more bearable and this is not to be sneered at. But participation in such committees has its dangers—the illusion that the worker has some control over his industry. The most dangerous of these types of committees are those concerned with productivity, job evaluation and labour rationalisation. The intention of the employer is to kid you that you are being consulted, you are being consulted on the most painless method of cutting your own throat.

The industrial democracy proposals will be discussed at the next Labour Party Conference, no doubt many delegates will feel forced to support it because they feel it is progress, even if it does not go far enough. There is only one way to deal with such a policy statement -reject it completely; it is presented in an attempt to siphon off militancy from the policy of workers' control. Workers' participation has the same effect as a mirage-when one comes round

there is nothing there.

John Stonehouse, Postmaster-General, former darling of the 'leftwing', informed a Fabian Society summer school that 'we must make a clear distinctin between workers' participation and workers' control. The former is acceptable but the latter must be ruled out'. Stone-house went on to say that workers' control was indefensible because, if a workers'-controlled management was operating a monopoly, they would be able without external constraints to hold the rest of the community to ransom.

Politicians can only think in capitalist terms and economics. Any system other than capitalism is inconceivable to them, hence this Stonehouse classic

## THE BUSMENS' FROZEN POUND

MOST WAGE EARNERS in Britainand there are more than 24 million of us!-resent the Government's law to hold down wages by means of that infamous Parliamentary Statute known as the Prices and Incomes Act.

This law gives the employers the legal right to keep wage increases down to a few shillings a week. Prices, rents, fares, and profits are all unrestricted. Only wages are held down. If ever there was a law specially designed to protect the employers' profits this is it!

Some resent this law more than others and those who resent it most of all are the people who directly suffer its effects. The provincial busmen fall into this category.

Three times have the Government intervened to stop payment of their freely-negotiated wage increase. Three times have these Ministerial creatures (whose average wage is £160 a week) decreed that the provincial busmen's basic wage of £12 8s. 3d. shall not be raised by a lousy £1. No wonder there is resentment and no wonder that resentment has now boiled over into actual

The provincial busmen have decided to stop work on August 12 to compel the employers and the Government to the 'frozen' pound. It is a decision which we applaud. At last someone is fighting back

If the strike actually takes place it will be in defiance of the law-and 70,000 busmen will all become 'lawbreakers', for the Prices and Incomes Act makes it illegal to strike once the Government has issued its decree. But this Governmentlike all so-called democratic governments -rules by deceit. They must have at least the tolerance of the people they govern-or they can't govern at all. So if the busmen's example is followed by us all, the Government will be powerless and its laws will be useless.

How can any Government 'punish' 24 Who would do million 'lawbreakers'? the work if all the workers are in jail? Where are the prisons that would hold them? And where will the employers get their profits if there aren't any workers to work? Let the people once resolve to defy the law and the law is finished. The people will be free of it.

All of us are hoping the busmen will win-but hoping is not enough. We must all take whatever action is necessary to MAKE CERTAIN that they win.

Passing resolutions of support and sending money is useful but much more will be needed. From August 12 there must be real demonstrations of support demonstrations in working hours that will show this Government that if they take on the busmen they must take on

We can't stand by and watch the bus-

men fight the Government all on their own. They are fighting for all of us. If they win we all win. If they lose we all

Workers of Britain unite on August 12! You have nothing to lost but the Prices and Incomes Act! You have your freedom to win!

ground and must have been in almost total permanent darkness. The attics were reached by cardboard-thin stairs which you had to crawl up since the roof hung so low. The masonry was perished, and crumbled at a touch.

The leaflets were distributed through doors and into people's hands. The warm neighbourliness of the street contrasted sharply with the state of the houses. Everybody's window was open, people shouted greetings to each other, talked in the back yards beside the wash-houses and air raid shelters. 'A better bunch of neighbours you couldn't want,' said one tenant we talked to for some time after giving him a leaflet. He added, 'If we stick out so long, the Council will repair the rotten sinks in the houses they've offered; if we stick out longer we might get them papered. A bit longer and we might get decent houses.'

This seemed to sum up the feelings of the street; they wanted to move, but wanted decent houses in areas where some of the community-feeling of the street remained. They weren't going to be steamrollered just for the bureaucrats'

Those who doubted the Council's determination to get the families out received a shock on Tuesday, the 30th, when it was announced that the city engineer, Carne, had applied to the sheriff for a compulsory eviction order against those in 40-42 Jasmine Terrace who had received the three-day vacation order. seems that the Council will try to crush the 25 people here involved and then hope that those under nine-day orders will go quietly.

FOOTNOTE: A report in the Press and Journal (1.8.68) suggests that the Council has capitulated to those in Nos. 40-42. Some of the families have moved into suitable accommodation, others are with relatives awaiting new offers from the Council. This report also mentions our leaflet. However, no new offers have been made to those on 9-day vacation For Workers' Control

Ralph Lord, secretary of the local busmen's branch of the Transport & General Workers' Union, said, 'They are sick to death of the Government.'

## Apprentice Pay Gut

IF THE MANAGEMENT of Vickers Shipyard don't think again about their decision to cut their apprentices pay before Monday next, there will be ructions. The AEF union district committee has given them notice that its adult members will strike, if no settlement has been reached by August 12, in the month long strike of 300-odd

The wage cuts, of up to 29/- a week, must be withdrawn if the shipyard is to avoid the stoppage. The lads themselves struck originally on June 3 and returned on June 25 for talks on the dispute. They got no satisfaction, so they came out again on July 8 and haven't gone back in face of management threats of legal action and the firm's decision to scrap indenture agreements on August 12.

Dear Comrades,

Jack Robinson is wrong to attribute the belief that 'enormous wage rises without a change in the political and economic structures equals a rise in the cost of living and return to misery in a few months' to anyone in Nantes. It is my Iron Law of Wages which I had thought universally discredited since my death nearly 100 years ago.

Fortunately the Labour Government ave revived belief in my theory that as wages rise so the cost of living rises. My friends Bakunin and Marx tried to discredit this by pointing out that employers paid the market value of labour and sold according to the market price of the commodity, and had a margin in their rate of profit. They said 'enormous wage increases' were often paid to executives without public to-do being made. Combination, they said, even in a capitalist society, could increase the market value of labour or cut the market price of goods.

But where would this have left the

political leadership who wanted to do all this by parliamentary legislation?
