# YOUTH LIBERATION

Well, in many years of frequenting amusement arcades, I've never been raped, mugged, or offered drugs or prostitutes. Have I been going to the wrong places?

As for kids wasting their pocket-money, being accused of wasting money by a local authority is like being accused of promiscuity by the "Happy Hooker".

## THE AGE OF CONSENT

We read, in such newspapers as the *News of the World*, of "TEENAGE SEX, BOOZE AND DRUGS". I believe that

the age of consent should be lowered to 14, and kids of 11 and upwards allowed to have sex with partners under 16. The drinking age should be cut to 14, and kids of 11 allowed to drink with parents' consent. Soft drugs should be legalised on the same basis as cigarettes. The "15" and "18" cinema certificates should be cut to 11 and 15 respectively. You see, I believe that we learn from our mistakes and that giving kids more responsibility will make them more responsible.

We read periodic shock-horror exposes of child labour. What's all the fuss about? What's wrong with kids working? Safety regulations should perhaps be tighter for everyone, and maybe there should be a minimum wage, but such things inevitably increase unemployment.
