## TERMS OF USE

#### 1. <u>General</u>

- 1.1 This document ("**T&C**") is an electronic record in terms of: (i) Information Technology Act, 2000; (ii) the rules framed there under as applicable; and (iii) the amended provisions pertaining to electronic records in various statutes as amended by the Information Technology Act, 2000. This electronic record is generated by a computer system and does not require any physical or digital signatures.
- 1.2 This T&C is published in accordance with the provisions of Information Technology Act, 2000 and the rules made thereunder that require publishing the rules and regulations, privacy policy and terms of use for access or usage of our website <u>http://shop.thebetterindia.com</u> ("Website") and our mobile application <u>http://shop.thebetterindia.com</u> ("Application"). For the purposes of this T&C, the Website and Application shall be together referred to as "Platform".
- 1.3 The Platform is owned, registered and operated by "Vikara Services **Private Limited**" ("Company", "we", "our" or "us"), a private limited company, incorporated under the provisions of the Companies Act, 2013 and having its registered office at Unit No. 402, 4th Floor, Prestige Feroze, No.74, Sampangi Ramaswamy Temple Street (Earlier Cunningham Road), Bengaluru, Karnataka 560052.
- 1.4 This T&C, the <u>Privacy Policy</u>, and the <u>Terms of Service</u> together govern the terms of use of the Platforms.
- 1.5 The Company operates the Platform to provide online access to information about the Company and the products, services, and opportunities we provide at the Company ('**Services'**). Please read these T&C carefully before you use the Services. If you do not agree to these T&C, the <u>Privacy Policy</u>, and the <u>Terms of Service</u>, you may not use the Services. ## 9. NON-ASSIGNMENT

9.1 You shall not assign or transfer or purport to assign or transfer the contract between you and us to any other person.

## **10. INDEPENDENT CONTRACTOR**

10.1 Nothing contained in this T&C shall be construed to create the relationship of employer and employee, principal and agent, partnership or joint venture, or any other fiduciary relationship.

## 11. NO THIRD-PARTY BENEFICIARIES

11.1 User acknowledges and agrees that this Agreement shall in no event be construed as a third party beneficiary contract, and that it is not intended for the benefit of any person or company whomsoever except the parties hereto.

# 12. GOVERNING LAW AND DISPUTE RESOLUTION

This T&C shall be governed by and constructed in accordance with the laws of India, without reference to conflict of laws principles. The courts in Bangalore shall have exclusive jurisdiction to determine any disputes arising in relation to, or under, the terms of this T&C. You agree to submit to the jurisdiction of the courts in Bangalore and agree to waive any and all objections to the exercise of jurisdiction over the parties by such courts.

#### **USE OF THE SERVICES**

1. Your account ("**Account**") will be automatically created using your mobile number provided at the time of checkout. You can login to your Account by entering your mobile number to which we will send an OTP (One time Password) via SMS. Once the OTP is correctly entered and authenticated, you will have access to your Account.

## 2. Linking your Account with Third Party Accounts

- (a) As part of the functionality of the Services, you may link your Account with a third party account ("**Third Party Accounts**"), by either:
  - (i) providing your Third Party Account login information to us through the Services; or

#### USER CONDUCT
