#### **ARMY CHIEF GEN NARAVANE TAKES CHARGE AS HEAD OF CHIEFS OF STAFF**

Army Chief Gen MM Naravane has assumed the charge as the Chairman of the Chiefs of Staff Committee that comprises the three service chiefs. The post fell vacant following the death of Chief of Defence Staff Gen Bipin Rawat in the IAF helicopter crash on December 8. Gen Naravane has been given the charge as the chairman of the committee as he is the seniormost among the three service chiefs. IAF Chief Air Chief Marshal V R Chaudhari and Navy Chief Admiral R Hari Kumar had taken over their respective positions on September 30 and November 30.

#### "SHE'S ALIVE!": INDRANI MUKERJEE **CLAIMS OVER SHEENA BORA**

Jailed former media executive Indrani Mukerjea, accused of murdering her daughter Sheena Bora in 2012, has written to the CBI claiming she is alive and has asked the agency to investigate, adding a bizarre new twist to the sensational case. Indrani Mukherjea claims she met a woman prisoner who told her she had met Sheena Bora in Kashmir, sources say, citing the letter sent directly to the CBI chief. "She wrote to the CBI, we have no details of what she wrote," said her lawyer Sana Khan today, adding that she will move a formal application for bail. Indrani Mukherjea, 49, has been in the Byculla prison in Mumbai since 2015.

#### NO DEATH DUE TO LACK OF OXYGEN **DURING COVID SECOND WAVE: UP GOVT**

The Uttar Pradesh government today told the legislative council that no death due to lack of oxygen was reported in the state during the second wave of COVID-19, a claim rejected by the opposition. The government said the death certificates made no mention of 'death due to lack of oxygen' in any of the 22,915 patients that died due to the pandemic. Replying to Congress member Deepak Singh during the Question Hour, Health Minister Jai Pratap Singh said, "No death has been reported in the state due to lack of oxygen during the second wave.

#### **MERELY LIVING TOGETHER FOR FEW** DAYS NOT ENOUGH FOR LIVE-IN TIES

The Punjab and Haryana High Court has observed that merely because two adults are living together for a few days, their claim of a live-in relationship based upon a "bald averment" may not be enough to hold that they are truly in a live-in-relationship. Justice Manoj Bajaj observed that it has to be constantly borne in mind that the length of the relationship coupled with discharge of certain duties and responsibilities towards each other makes such relationship akin to the marital relations. The court dismissed the plea of a couple of Haryana's Yamunanagar district seeking protection from the family members of the woman

# Bill on increasing marriage age of women from 18 to 21 years

- Govt to bring a bill in the ongoing Winter Session
- Experts flag concern

PNS ■ NEW DELHI

The government has decided to raise the legal age of marriage for women from 18 to 21 years, bringing it at par with that of men. Experts, however, have raised

concern over the decision, saying the move is akin to treating symptoms instead of the underlying causes.

The Union Cabinet had on Wednesday cleared a proposal to bring in uniformity in the marriageable age of men and women, sources said on Thursday.

The government is likely to bring a bill in the ongoing Winter Session of Parliament to amend the Prohibition of Child Marriage Act, 2006, they said.

The proposed bill may also seek to make consequential changes to various personal laws relating to marriage of different communities to ensure a uniform marriage age, the sources said.

As of now, the legal age of women to get married is 18 while that for men is 21 years.

The decision came a year after Prime Minister Narendra Modi said the government was deliberating on what should be the minimum age for

chief Jaya Jaitly. Speaking about the recommendation, Jaitly said there were two main reasons that were focussed on.

"If we talk about gender equity and gender empowerment in every field, we cannot leave marriage out because this is a very odd message that a girl can be fit to be married at 18 that cuts away her opportunity to go to college, and the man has the opportunity to prepare himself for life and earning up to 21 years, she

"We should give the girl an oppor-

tunity to earn and be equal to a man and she cannot become equal at 18 years when man has 21 years to do that. Secondly, we took opinions from lots of people, but the main people who were most attentive were the stakeholders themselves.

We conducted assessment calls with young people -- universities, colleges and in rural areas -- where they are still at school or getting out of school and the unanimous opinion of the stakeholders was the marriageable age to be 22 or 23 years. Across all religions everyone had the same opinion which was a very heartening thing," she said.



#### Four more test positive for Omicron in TS

Four more Omicron cases have been detected at RGIA in Telangana. One international traveller from an 'at risk' country and three others from other countries tested positive for the Omicron variant of Covid-19. With this, the total number of Omicron cases in the state has gone up to 7.

Director of Public Health Dr G Srinivasa Rao said: "We got four imported Omicron positive cases on Thursday. Out of these, three are from Kenya and one person is of Indian origin. Investigation is on and we will share further details on Friday morning".

Telangana on Wednesday reported the first case of Omicron with two air passengers from Kenya and Somalia testing positive for the new variant of Covid-19. About 120 passengers arrived in the state on Thursday, no one tested pos-

Further, one sample was sent for genome sequencing. From the random sampling of those from coming non-risk countries, three persons tested positive. With this nearly 6 people from non-risk countries tested positive for Omircon.

The results of samples of three more persons are awaited.

# **NFWT**: Nix regressive, undemocratic concepts from CBSE syllabus

Takes strong exception to attempts to create gender bias Demands unconditional apology from CBSE officials

The National Forum for Women Teachers (NFWT) has taken strong exception to certain regressive and anti democratic narrative that had crept into the question papers related to CBSE syllabus in 10th and 12 th standards.

"Children have been going astray in families where women do not give value to their husbands' views. There is growing lack of discipline and families are disintegrating. This is all due to excessive freedom The foregoing was

a paragraph (meant for comprehension) in the latest English language question paper of 10th standard, M Sanyukta, NFWT Chairperson and STFI National Vice-President, pointed out in a statement here on Thursday.

In yet another instance, there was a question with multiple answers in Sociology question paper related to 12 th standard - Who engineered attacks against Muslims in Gujarat in year 2002? The multiple answers provided were: BJP, Congress, Republican and

After nation-wise protests and criti-

cism concerning these question papers, CBSE authorities said it was a 'printing' mistake and that an inquiry would be ordered and action taken against those

The NFWT members said action should be taken against those who had set the question papers and others connected with it. Examination papers had questions which were not relat-

ed to syllabus. The syllabus of 10th and 12 th standards should be reviewed and scrutinsed and undemocconcepts

should be removed, they demanded. NFWT The Chairperson and other members said that those who had formulated the New Education Policy -2020

and those involved in its compilation must be those believing in 'Manuvadi' thought

In a democratic country like India, backed by Constitution which provided equal opportunities to all, girls and women had been proving themselves and raising their voice for their rights and questioning atrocities and injustice. They had been stating that men too have responsibilities in bringing up children and running the household. However, those men who subscribed to Manuvadi doctrine were including topics in the syllabus that would sow seeds of discrimination and regressive concepts into the minds of young children. If this trend was not nipped in the bud, it could also spread to syallabus in various States, they reasoned.

At a time when Science and Technology was making rapid strides, instead of including topics that would encourage scientific attitude and temperament, CBSE unfortunately included topics that would belittle women. By doing so, what kind of guidance the CBSE chose to provide to the future generations of the country, they wondered. The NFWT questioned. "How can the objective of Beti Bachao, Beti Padao' be accomplished with this kind of thought process?"

The CBSE should immediately remove from syllabus such concepts that would create misconceptions about their mothers. Such ideas would be detrimental to women who were going forward by fighting against the hurdles and confine them back to kitchens.

The NFWT demanded that the CBSE syllabus be reviewed and re-oriented with a democratic and progressive spirit enshrined in the Constitution. The board should tender an unconditional apology for hurting the sentiments of women. The CBSE syllabus should be enhanced and improved to reflect the democratic spirit, constitutional values, and scientific thought, the

Jaitly said the task force submitted its recommendations to the PMO, Ministry of Women and Development and NITI Aayog last December.

The other members in the panel include V K Paul, member (health) NITI Aayog; secretaries of higher education, school education, health, women and child development, legislative department apart from academicians Najma Akhtar, Vasudha Kamat and Dipti Shah.

Amita Pitre, Lead Specialist, Gender Justice, Oxfam India,

said the latest NFHS 5 report shows that the number of women marrying early (before 18 years) has reduced from 27 per cent in NFHS 4 to 23 per cent.

"Even so nearly, 50 to 60 per cent of marriages still take place before the age of 21 years. Raising the age of marriage to 21 years will criminalise all such marriages taking place in future. The minimum age of marriage has been 18 years since 1978. Clearly law alone is not successful in raising the age of marriage. In upper and mid-dle classes, girls marry much beyond the age of 21 years and this happened without the compulsion of law," he said. The official added that the harms of criminalising marriage of girls below 21 years

are manifold, which even

manifest for those married

Population Foundation of India said increasing women's age of marriage is like "treating symptoms instead of the

"While the concern with early marriage is a step in the right direction, legal action on this issue is akin to treating symptoms instead of the underlying causes which have allowed such a practice to

exist for centuries. A whole range of factors such as deeprooted gender inequality, regressive social norms, financial insecurity, lack of quality education and employment opportunities together contribute to the incidence of early and forced marriages," it said in a statement.

He had taken charge from D Nagaraju who initially investigated the case. Vasudevan had examined a few witnesses as part of the investigation which was transferred to him from Nagaraju.

Later, acting on the court's direction, the case investigation was transferred to the CBI. Vasudevan met CBI SP Ram Singh who is leading the investigation team on September 1, 2021 at Kadapa central prison guest house.

In the letter, Vaudevan also said that initially a case under Section 174 CrPC was registered citing death cause unknown and later after the Panchanama FIR was registered under section 302 of

"CBI Ram Singh had asked me if CI Sankaraiah had given a statement to me that on the day when the murder came to light if Devireddy Siva Sankar Reddy had taken the CI to a corner of the deceased house and intimidated him. When I denied any such statement from Sankaraiah, the CBI SP had turned impatient and velled at me and said we all manipulated the investigation and

weakened the cases while going around the political leaders for postings," Vasudevan said in the letter to the SP.

Vasudevan also said that CBI SP charged him that he was posted as SDPO of Pulivendula with the help of an influential politician that suits him. "I vehemently denied that mine was a political posting.

I told the CBI SP I was given the posting purely on my meritorious 30 years of service track record. I also said there was no pressure from any politician on me during the course of the investigation. After that, the SP turned impatient towards me again," Vasudevan said.

YS Vivekananda Reddy who is uncle of chief minister YS Jaganmohan Reddy was found dead under suspicious circumstances at his Pulivendula residence on March 15, 2019. The Andhra Pradesh government had constituted three SITs to investigate the murder. The SIT examined at least 1,300 witnesses and conducted a narco analysis on three suspects. Three persons have also been arrested on the allegation of tampering with the evidence. At least two teams of CBI have been changed during the course

Based on the confession statement by a key accused in the case, Sheik Dastagiri who was a former driver of Viveka, another accused Devireddy Siva Sankar Reddy who is a key aide of Kadapa MP YS Avinash Reddy has already been arrested by the CBI.

Devireddy Sankar Reddy was behind the murder and that he

had offered Rs 40 crore as



# **Coming of age**

The Govt wants women to marry not before they turn 21 so they can take better hold of their lives

The Union Government proposes to raise the legal marriageable age of women from 18 to 21, the same as men, by amending the marriage Acts concerned. The Government will have to clarify whether the amended age will be applicable to personal laws of all religions. The proposal is based on the suggestions sent to NITI Aayog a year ago by a Central task force that examined "matters pertaining" to the age of motherhood, imperatives of lowering Maternal Mortality Rate, improvement of nutritional levels and related issues". The task force, however, was quick to point out that empowerment of women was its primary consideration. The proposal ticks all the right boxes. It is one more way to assert that child marriages and marriages of minors are illegal. It should steer families towards adapting to changing times and encouraging young adults to take independent decisions instead of rushing them into marriages the moment they get their undergraduate degrees. The vounger generation does not want to be thrust into marriage just as they leave their teens and the proposal backs their thought. It clears the path for women to become



It is that the country is making a conscious decision to create circumstances for women to take hold of their lives. We must remember that till 1978. women's marriageable age was only 15, which was then raised to 18. Women have moved up on the ladder of choice and parity in the four decades since then and are conscious-

ly pursuing higher studies and professional careers like never before. If the age limit ensures women are not married off before they attain mature adulthood, it is also a caution that they are not married off the moment they attain the age of consent. The point of the exercise is to respect women's right to consent. The limit also discourages the marriage of minors, a social evil still prevalent in several parts of the country. It means women should be able to convince their families that at 21 they are mature enough to exercise their choice about all things in life, including, and especially, marriage. Empowerment is not selective. It is not conditional. An empowered woman has the right to educate herself, make adult choices vis-à-vis relationships, take up employment and choose the time to have a life partner. The right gives her the choice to not choose as well. That is the critical point that society at large needs to understand. Otherwise, empowerment has no meaning. Needless to say, the biggest responsibility of respecting everything the proposal stands for lies with the State apparatus.

The Centre must not rush to ban it as cryptocurrency is the future, say experts

The winter session of Parliament is on and the Government is planning to bring a Bill on cryptocurrency. Locally, it is being dubbed a Bill to ban, or at least regulate, cryptocurrency. It had an impact on the crypto market and Bitcoin tumbled down 15 per cent before staging a recovery. For nearly 10 years now, cryptocurrency has been in news and its exponential growth has made instant billionaires, which led to a mad rush for Bitcoins. It has also opened an additional hawala route to transfer funds. Why is the Government so keen to ban it? Its alarm may



es like procuring drugs and arms through the darknet, a hidden internet used by fugitives. The Enforcement Directorate has discovered that ₹4,000 crore were laundered out of India using cryptos last year. Though indeed a serious problem, crypto is not the only way to make such transactions. There are several other nefarious routes, and these continue unabated.

Cryptocurrency is not issued by any bank or Government but by anyone who wants to float his currency, just like airlines offering 'flying miles' or malls issuing their plastic money. Therefore,

nobody — least of all a Government — has any control over it, which means regulating or banning it is nigh impossible, even though a number of Ministers have hinted that it may get banned. The Government can at best declare it to not be a legal tender, which it isn't in most countries barring a few South American nations such as Ecuador and Chile. No doubt the concerns are many, but would it really be possible for the Government to control or, for that matter, ban it? If yes, would it be in the nation's interest? What happens to the 'Digital India' drive as experts feel that cryptocurrency is here to stay and, in future, it would be the mainstay for online transactions. The Government would do well to wait and watch rather than jumping the gun and deciding in haste. Except China, no country has so far banned cryptocurrency. In fact, many countries with weak currencies are promoting it. Even the US, the UK and France have not tried to control it. Crypto is the future and it won't be possible for any single nation to control it; it has to be done collectively. Banning it would in fact be a setback for 'Digital India'!

# The land of freedom and democracy




At Biden's 'Summit for Democracy', Modi appropriately underlined the point that the democratic spirit is integral to India's civilisational ethos

t is safe to assume that US President Joe Biden had in mind only electoral democracy when he invited many a head of Government to his December 9 'Summit for Democracy'. Prime Minister Narendra Modi made a telling point when he said that the democratic spirit is integral to India's civilisational ethos. Centuries of colonial rule could not suppress the democratic spirit of Indians. He avoided extending the proposition to a faith in the phenomenon of karma which is nothing, if not democratic, on a metaphysical scale. All humans have a fair and equal opportunity to be automatically rewarded with or denied a bhagya or fate commensurate with her/his karma without a divine entity, say God, having an overriding say in the *bhagya*. The belief in the operation of karma is like the law in physics that for every action, there is an equal and opposite reaction. This is a faith as near science as yet possible.

Another symptom of Indian democracy is its history down the ages. Anyone who arrived whether via the Hindu Kush or Arabian Sea as the early Jews or ther traders, the Parsees, British and many others were welcome, or at least allowed to stay and settle on Indian soil. No one was expelled regardless of eing cruel or kind.

The idea behind the open welcome to one and all was that the world was one family, Vasudhaiva kutumbakam. An advantage of this policy — call it Indic — or conduct was that the culture-cum-civilisation became resilient and, regardless of its disinclination to fight, survived against any number and kinds of invasions. Few cultures could withstand it and survive. It began with the advent of the Caliph and his successors, from Arabia, on to Egypt and the Mediterranean countries certainly up to Spain. with the intent of saving Indira's hold on power. Except for those 21 months or so, India's record of electoral democracy has been commendable.

Even when dealing with Mohammed Ali Jinnah and the Muslim League during Partition, India's behaviour was, if anything, overdemocratic. In anticipation of the separation, the Qaid-e-Azam and his colleagues were insistent that all Muslims should be facilitated to migrate to the new Islamic country, their homeland. They were at times so vehement as to insist that all Muslims should migrate from India. In his rabid enthusiasm, one of the League bigwigs Sir Firoz Khan Noon thundered in February 1946 in Patna that if the Hindus in India came in the way of the transfer of Muslims to Pakistan, the League would re-enact the orgies of Chengez Khan and Halaqu Khan.

Indian leaders remained allowed to decide for themselves. An Exchange of fore, democracy. Population plan was proposed and supported by Jinnah whereby Muslims, preferably all of them, would migrate to Pakistan. And

reciprocally, all non-Muslims would move to India. Rajendra Prasad, who subsequently became the President of independent India, wrote a book entitled India Divided wherein he suggested that those Muslims who didn't emigrate could stay in India as aliens with visas issued by the Government of India. The same could be done by Pakistan to the non-Muslims who remained behind in that country.

Jinnah promptly agreed with Prasad. Yet, the other Congress leaders kept quiet. In the end, Pakistan, with the help of violence, loot and killing chased out most Hindus whereas Muslims were allowed to stay back in India if they wished. Some went away from East Punjab (India), UP and Bihar but compared to Pakistan, India did practically little. This is true to this day, 75 years later.

This was the practical essence of democracy. It is calm and implied that difficult to think of any other Muslims were also their example of such devotion to brothers and they should be freedom. India is indeed the land of freedom and, there-

### **FIRST COLUMN INDIA'S CONNECT: A CENTRAL ASIA POLICY**

Despite a solid economic partnership with China, central Asia is well aware of its deceitful nature

eaders from five central Asian countries comprising of Kazakhstan. Turkmenistan, Tajikistan, Kyrgyzstan and Uzbekistan could be the chief guests on the next Republic Day. This comes close on the heels of the Russian president's tour to India that re-emphasized Indo-Russian strategic friendship. All this happens in the backdrop of India finding new strategic allies such as the US, and Russia's growing intimacy with China and Pakistan. It brings the focus on the big global powers trying to recalibrate their strategic, geo-political and military alliances in a post-COVID, multipolar and a more transactional world order. India, therefore, has made the right move by focusing on a specific regional cluster of nations, i.e., Central Asia, within its larger foreign strategy. If the heads of state of the five Central Asian republics attend as chief guests on January 26, 2022, it would be the second occasion after 2018 when regionally important ASEAN leaders had been the chief guests. It would



be a good optical moment for India to showcase its increased influence over the central Asian republics, specifically to China and Pakistan. The five countries share land borders with Afghanistan and some also with China, Russia and Iran. The Afghanistan situation is increasingly threatening to spill over and start impacting the rest of the landlocked neighbors and beyond. The immediate threats are a barrage of illegal Afghan immigrants spilling into these five countries and onwards to Russia and perhaps China and Iran, too. There are additional threats of drug and human trafficking, terror activities and smuggling and the whole of Eurasia starts feeling the tremors. India has a unique position in the relationship because of its historical, cultural and infrastructural linkages with these countries in the past; even though it is now isolated due to its evolving relationship with China and Pakistan. Pakistan, and by proxy China, would not spare a chance to use the Taliban-trained militia to create problems for India. China and Pakistan have significant political, economic and strategic interests in Afghanistan that serves as a key gateway into Eurasia for them. China, dictated by its expansionist foreign policy almost teetering towards colonization, steadily strengthened its economic relations with Central Asia over the years. The annual trade between them is approximately \$100bn compared to India's less than \$2bn with the same group of countries. That leaves a yawning gap for India to fill by nurturing a strong relationship with them at the earliest.

India was one of the first countries to officially recognize these Central Asian republics in the 1990s. Prior to that, India's engagement with them was through the erstwhile Soviet Union. In the past three decades, India has hardly developed meaningful partnerships with these geo-politically important countries neighboring Afghanistan. In wake of the current Afghan crisis and a gradual recalibration of the global order, lethargy of the past has to be dropped. Central Asia despite having a robust economic partnership with China is well aware of the deceitful nature of the Dragon. They are also more influenced by Russia and Iran for their security, and strategic interests. Russia, even though it has an empathetic view of China's narrative on the evolving global order, knows that India is a tried and trusted friend in the region who can be a balancing component. Therefore, Russia would also encourage these central Asian countries to expand their security, economic partnerships with India and have complementarity of policies on regional concerns such as terrorism, drug trafficking and Afghanistan. India has done well by rekindling its Central Asia connect policy (first conceived in 2012). The roads from Tashkent to Thiruvananthapuram and Samarkand to Surat need to be built.

# Poor hygiene brings the economy down







The challenges in accessing adequate water supply, sanitation facilities and poor hygiene practices lead to a rise in diseases, causing increased economic burden

ccess to hygiene and sanitation facilities is a fundamental human right and one of the key determinants of health. According to the 2017 'Household Survey for the Assessment of Toilet Coverage under Swachh Bharat Mission, 39.9 percent of India's rural population defecates in open and about 26 percent people do not use soap or detergent to wash their hands afterwards (National Sample Survey 2019). The challenges in accessing adequate water supply and sanitation facilities coupled with poor hygiene practices lead to a rise in diseases which can result in higher economic burden, exceeding investments in hygiene and sanitation

The sixth Sustainable Development Goal is to 'Ensure availability and sustainable management of water and sanitation for all' by 2030. Since Water, Sanitation and Hygiene (WASH) programs have a direct impact on health and socio-economic indicators, they have played a central role in improving India's overall health over the past decades. Hygiene, water and sanitation programs are a proven cost-effective investment for public health.

Ever since Independence, WASH Programs have been synonymous with the country's public health agenda. Too many lives have been lost to preventable diseases such as malaria, diarrhoea, cholera, smallpox and other infectious diseases - all caused by poor hygiene, sanitation and inadequate water supply. As a result, the Government of India put emphasis on improving health indicators with a focused approach towards water supply and sanitation across the country.

In the 10th five-year plan adopted in 2002, the role of sanitation and hygiene were intrinsically linked to the objectives of reducing Infant Mortality Rate (IMR); Maternal Mortality Ratio (MMR); ensuring completion of five years of schooling for all children by 2007 and providing potable drinking water in all villages. The Swachh Bharat Mission and the Jal Jeevan Mission are two recent government initiatives aimed at improving the supply of clean water and moving the country toward sustainable sanitation standards. While the Swachh Bharat Mission was aimed at achieving universal sanitation coverage, the Ial Jeevan Mission sought to ensure piped water supply for all households in the country; providing a significant boost to the rural water and sanitation industry. According to Lancet's 'The Global Burden of Disease' study, through these efforts India managed to add quality years of life expectancy to its people, indicating a substantial increase in the overall health of the country.

However, given the wide inequalities in the social and economic demographics of the population, India continues to experience mixed progress in terms of hygiene

and sanitation-related outcomes. The economic consequences caused by inadequate access to sanitation has reper-

itation in India estimated that the country lost the equivalent of 6.4 percent of GDP due to inadequate sanitation. Over 70 percent of it (₹1.75 lakh crore) was accounted for by premature mortality and healthrelated costs. While social impacts are difficult to quantify, some risks are often exacerbated, affecting the most vulnerable groups including women, children and people with disabili-ties. For example, poor pregnancy

outcomes, maternal mortality, violence and psychological stress are some of the serious consequences of lack of access to clean water and sanitation among women and girls. Inadequate access to WASH can also lead to vulnerability, rape and attacks, and the fear of such assaults can prohibit women and children from using toilets and sanitary facilities outside their homes at night. Similarly, problems of dignity, safety and privacy to maintain good hygiene get compounded for lisabled persons as they experience increasing feelings of disgust, fear of violence, injury and shame due to lack of proper hygiene services.

To overcome the issues related to hygiene and sanitation and prevent its negative socio-economic impacts, communities governments, private sector and development partners must make collaborative efforts towards innovative solutions. Governments and supporting agencies need to foster innovation, especially from the commercial sector, to make hand hygiene a universal practice in all contexts. To tackle issues of shortage of water, inaccessibility and unavailability of hand washing facilities and soaps, new solutions are urgently required. Multi-stakeholder collaborations in such situations assume an important role in providing market knowledge and recommendations on enhancing hand hygiene and

strengthening WASH facilities.

A collaboration between the
World Bank, UNICEF, Johns Hopkins University, USAID and Unilever to form a Public-Private Partnership for Handwashing in 2001 is a case in point. More notably, Unilever has been involved in tackling epidemics such as cholera and has been able to reach over 1.2 billion individuals with programs and awareness campaigns through their Hygiene and Behaviour Change Coalition partnerships. Through close collaborations with Government/ public enterprises, HBCC has been able to advocate for hand and surface hygiene among the vulnerable slum populations even during the COVID-19 pandemic.

Interventions to promote hand hygiene should also be founded on a thorough understanding of what people care about, and should incorporate appropriate social norms to help build sustainable habits. The emphasis needs to move towards a transformative approach focusing on needs of the community, going beyond the benefits of WASH in sanitation research and programming and eliminating the less safe forms of sanitation. Projects like NISHTHA, USAID's flagship health system strengthening project being implemented by Jhpiego in partnership with Unilever, support various state governments in leveraging the Health and Wellness Centres (HWCs) platform under Ayushman Bharat. One of the key

aspects of this project is the health and wellness session, where local communities are educated on the importance of healthy hygiene. Considering the local context, this project leverages on existing limited resources and funds to establish handwashing corners and appropriate social norms to strengthen handwashing behaviours.

Transformative approaches to hygiene and sanitation require stronger governance, management and increased accountability. There is a need to build capacities of health workers and sanitation workers, create mass awareness among the larger public and collaborate with the private sector and other partners for investing in the area of WASH. This would not only ensure access to sanitary facilities to households but would also empower people to take sustained action at local levels.

Overall, investments in toilet usage, hygiene promotion, increased access to potable water, and effective waste management are estimated to save India \$32.6 billion (₹1.48 trillion) or \$29 (₹1321) per capita, according to a Water and Sanitation Program report. Improved sanitation yields several economic benefits, including direct benefits such as avoiding illnesses (the sum of money saved on healthcare expenses), indirect economic benefits such as fewer sick days and a longer lifespan because these benefits permit people to work more. As estimated by WHO, every dollar invested in hygiene and sanitation provides a return on investment for the society of \$5.50 due to lower health costs, increased productivity and fewer premature deaths. Therefore, it is imperative to carefully shape policies and regulations that prioritize and adequately fund hygiene and sanitation.

## Trial of new oral drug against COVID-19 begins

Oravax Medical Inc, a subsidiary of US/Israeli pharmaceutical company Oramed, has started the first phase of clinical trial of its oral COVID-19 vaccine in South Africa.

The open-label trial involves participants who have not received either a COVID-19 vaccine or contracted the virus. Participants will be administered one dose of the oral vaccine at the beginning of the trial and a second dose three weeks

The trial's endpoints will include safety and tolerability as well as efficacy by measuring the presence of an immunogenic

# Dara Sandhu, the secret superstar

he lead antagonist Dara Sandhu from the European film And Tomorrow We Will Be Dead directed by none other than the award winning Swiss filmmaker Michael Steiner, was actually once an assistant director for such famous films like Aeh Dil Hai Mushkil & Secret Superstar. It took no time for him to become the face of an international film now, turning the tables for the better.

In conversation with the actor who also featured in the recent popular web series called *Masaba Masaba*, we got to know the kind of hard work he has put in to be the leading rival for the European film. Within the film fraternity, he did have a large repertoire yet he didn't choose to go the short-cut way. The foremost notion for us to get in touch with this very versatile persona was to know how his latest film was talking primarily about the importance of the political and human crisis in Afghanistan and how it affects people from all over the world! All of us are aware of the human tragedies that us are aware of the human tragedies that took place in Afghanistan recently, it became a worldwide rage and with this unusual interview with an actor, we tried getting to know more such insights on how one is able to film sensitive concepts like this and then make it a success too. Beginning with the Pashto twist that he has given, when one sees the film, it's difficult to sit back and not applaud him for the same.

He exclusively reveals to us, "The filmmakers made sure there were not the slightest of mispronunciations in Pashto. I have a natural tendency to pick up accents and language. I travel a lot and often find myself emulating accents from the places I visit. I have been to Kashmir several times and always speak with the locals in their accent only. It's not too far from the way Pashto can sound! It's intimidating at first, learning your Pashto lines is one thing, but remembering the nuances of each pronunciation during those high crash scenes can be quite challenging. You get entirely engrossed in the scene and forget the correct tonality for some words. Sometimes I mess around on Instagram making short comedy skits in different languages but the magnitude of this project and the director's insistence on acing the Pashto like a native speaker made it challenging for me. We also had the added responsibility of nailing our performances given the fact that the survivors were watching the film too and hoped for an authentic portrayal of their story.

It was the director of the European film that drew the AD-turned-actor to grabbing the project! Dara finds Michael Steiner's body of work to be an extraordinary vocation in itls own. According to Dara, Michael is one of the most popular European film-



makers! The movie is a real life story leading to a shocking revelation. Dara feels that in India we mostly visualise characters like Ommara as one dimensional or a negative character but he clears the air saying that wasn't the directors' apparition and treat-ment to the film. The actor's character is

scary and unpredictable at times and then shows a more human side all of allowed him to portray a range of emotions! The number of teary-eyed

people that walked up to him after the premiere in Zurich to tell him how much they loved his performance was a very special feeling for him indeed.

Chatting more on his long-found love for the ace director, he says, "I was nervous at first as Michael Steiner is one of the

most celebrated European filmmakers and is the only director to have opened the Zurich Film Festival twice, but Michael is as chilled out as he seems and is intelligen too. Michael and I are friends now and we have had lengthy conversations about western alternate culture and eastern philosophy. On shoot I would wake up earlier than required just out of excitement. The way the film was being made each day was an adventure for me! In general I found the Swiss to be very smart workers."

Dara Sandhu did manage to cross cultures and with that at times unfortunately one tends to face racism given the circum-

We were keen on knowing whether he faced subtle racism all this while and this is what he had to say, "First things first, I always wanted to play an antagonist. Playing an adversary is more accurate in the art of acting, like bad boys have all the fun. Jokes aside, even my character was critical to the story and the director flew down to do extensive readings and auditions with me after I was shortlisted. One of the primary things we worked on was ensuring that my character had such a compelling backstory that at no point did I feel like my actions were evil or incorrect! By the time I was on set I could justify my actions. It was the only way my character could survive his poverty. Coming to racial discrimination now, I travel a lot and I have been in situations where people look at a tall brown man suspiciously sometimes! It used to be the worst in America after 9/11. I went to boarding school in England and when you land up there with a thick Indian accent, you end up in some awkward situations. But otherwise my experience studying and working in England has been on equal opportunities regardless of colour. I think more than racism you tend to stack up against favouritism but that's prevalent everywhere, more so in India and Bollywood I might

While wrapping the conversation, we were wondering what will be the movie's impact on Swiss people who witnessed this event unfold on TV! To this he concludes and tells, "The level at which the audience was able to relate to David and Daniela's story was astounding. Everyone who spoke to me at length would remark that I have a warm personality in person but they were scared of me while watching the film. That is one of the best compliments an actor can get! The movie has gained unprecedented traction because of the developments in Afghanistan. In Switzerland they are viewing it as not only the ordeal of two Swiss hostages who spent eight months with the Taliban but also an insight into the world of Afghani people. The movie was inaugurated by the Swiss President Guy Parmelin and had the honour of opening the Zurich Film Festival amongst European film and political personalities

# Bridging gap between education & workforce demand

Engineers fresh out of college usually struggle in the professional world because their theoretical studies do not cover the daily difficulties of the working world. Maybe during college, the right guidance could change how freshly trained professionals advance in their career! Bridging this gap between a student's inexperience and the demands of a workplace is a new program at BITSoM. Dr. Ranjan Banerjee, Dean of BITSoM shared that there are many things today's graduates are not aware of before they go out into the career world — The dynamics, pivots and exposure of the MNCs. "Let it be about managing work, sustaining in the competitive market, closing a deal or politics within the organization, few things aren't taught in the classroom. They can only be attained when you face the world and learn through your experiences. That's where a mentor comes to rescue." The ability to seek out mentors in your life or work is very essential, as you get to build a network and ask queries. "A lot of mentor and mentee relationships start one way but they can be two ways. There can even be a reverse mentorship to evolve. As the comfort is built, even mentors can learn from mentees. Essentially it's about having conversations about the industry, seeking guidance in the behavioural domain and being industry ready."
Says the dean, "For me what stands out from this program is what a person can learn in one on one conversation with the people who have 20-25 years of experience. For many of those who go into the industry, it'll take 5 or 6

years to find a good mentor and

the right guidance. You know

nobody talks about it, but this is the basic need. By having a mentor, you're not only receiving a lot of helpful information, but you're also able to build a network of contacts through the mentor, if you go in search of more guidance than what your mentor can provide." He says that mentors also get to learn and have exposure, by connecting to the new latest generation workspace and there is a larger value of giving back.

Speaking about how the program has been received by both parties, he said that when they launched the program, they did a mentor meet and a mentee meet and noticed that the overall response was quite positive. "We are a new institute, and we are setting up to become a world class Business School. Our first batch just joined in July." Saying that they're probably the first institute in India to organize comprehensive mentorship for every student in the institute, Dr. Banerjee mentions that they've roped in senior executives of whom a few are alumni of BITS Pilani, and a few are executives from organizations, to mentor students. People have reported that they enjoyed the interaction." He said that the students got insights of the organizations, work process, perspectives and shared experiences. Often they work on the aspects and capabilities they want to build, it could be

SAMEER BAWA experiences an indulgent evening with fine wines and gourmet food accentuated by excellent service at Taj Palace

T's a bus, no it's a train, oh, it's the Orient Express! The train that defined luxu-Lry and comfort, before air travel came into vogue (1919 - 1977), has a namesake at the Taj Palace Hotel in New Delhi. The at the Taj Palace Hotel in New Delhi. The fine dining European restaurant which is celebrating its 38th anniversary offers luxury, comfort and great food on the lines of what the passengers experienced on the transcontinental journey from Paris to Constantinople (Istanbul) back in the day. The interiors of the restaurant are replete with deep armchairs, intricate panelling, oriental rugs and fine cutlery which mirrors the dining car of the original Orient Express.

I went in for an elaborate five course dinner last evening and thoroughly enjoyed the overall experience. "It's a rediscovery of Europe's culinary joys", says Ananya Mukherjee (Director PR & Marketing). The novel menu blends new and innovative preparations with the classics and, in a very special way, recreates the route of the journey.

We started with a selection of breads with Chicken liver pâté and butter on the side. Perfect accompaniment to my chilled tulip of sparkling wine. Starting off, I had the Camembert cheese soufflé with paprika sauce. The French classic preparation has been mastered by the Chef and was light, fluffy and perfectly balanced. Just a sprinkle of freshly crushed black pepper and every bite was divine. For the soup, I requested for the Essence of roast fennel and celery root, broiled pepitas seeds. Light and fragrant, the soup was exactly what and fragrant, the soup was exactly what I needed to revy up my appetite and perfect soul food for the nippy December evening. You could get a hint of aromas of the fennel when the broth was poured over pepitas seeds. Definitely, one for people who are counting the calories.

For the mains I requested for the New

For the mains, I requested for the New Zealand lamb chops encrusted with herbs, almonds and drizzled with rosemary jus. And that, ladies and gentleman, was the show-stopper! Between medium and well done, the juicy lamb was an explosion of flavours in every bite. Perfumed with rose-mary jus and garnished with almond crumble, the texture and taste were on point. One preparation that touches all your senses. You get the umami from the meat, the hint of salt and sweetness from the jus and the very slight bitterness from the almonds which made it a really well rounded dish. Absolutely loved it.

Culminated my meal with a Baileys crème brûlée which was nice but I thought the caramelised sugar on top could have had a bit more crunch and maybe burnt for a bit longer. They also had the very popular Warm chocolate pudding with liquid chocolate centre on the menu, which, off late, has been a regular feature on almost every restaurant menu. I have tried it before and its brilliant. I possibly would also stick my neck out and say that the Chefs at Taj have mastered it to the T.

All in all it was lovely indulgent food accentuated by excellent service. The







staff at the Orient Express is very well trained and have a keen eye for detail. They are happy to help you with selection of wines and at the same time equally at ease to recommend dishes from the menu that match your palate. I strongly suggest that you make a plan to experience the Orient Express if you have not tried it as yet. In my humble opinion, they have a knack of transforming a regular meal into an occasion.

### EDIBLE INGREDIENTS FOR A HEALTHY SKIN

Winter months in and around the NCR are harsh on the skin, especially on account of the pollution. But if you believe that you need to splurge on salon visits or on expensive creams and moisturisers, junk the thought. You can take care of your skin without the use of chemicals that will bring out the natural glow and radiance.

The very first step, if you are a smoker, is stop smoking. Though we always attribute smoking to lungs and heart diseases, it also hastens ageing of skin and creates pigmentation. Follow this up with staying hydrated and ensuring a good night's sleep. During the winter months, we tend to drink less water but it is very essential to remain hydrated. Water is a key constituent of healthy skin. The combination of a good night's sleep and hydration help to rejuvenate the skin.

□To stay warm and comfortable, we tend to layer ourselves. While layers keep us nice and warm, these impede the breathing of our skin, resulting in dryness and itchiness. Simple home-made moisturisers can do wonders for our skin. A couple of simple and easy to make moisturisers are -

\*Mix aloe vera gel, rose water and a pinch or two of turmeric. Make a batch and store it in a cool place. Use it every day to nourish your skin

\*In aloe vera gel add a pinch of turmeric, a little almond oil, a dash of rose water and the contents of six Vitamin E capsules. Give the mixture a good shake and your nutrient-laden moisturiser.

While the body remains covered, it is the face that is exposed. We go to great lengths to add shimmer to our face and end up using a variety of creams, serums and lotions to bring out the radiance. But do you know that you can make your own effective home-made remedies to have a glowing face? I have for long propagated that you should use those ingredients on your skin that you can eat. You do not have to be a spendthrift to have a glowing skin or face. All you need is resilience and time. For starters, make a face pack using ground flax seeds, rose water loe vera gel. Apply this pack at least twice a week for 15 minutes at night and

Make a juice of cucumber and mint leaves. Keep it in a spray bottle and spray the mixture on your face once in a while. This will keep the skin hydrated and is an excellent toner.
