Topic: AGENT GERMAN'S RETURN AND PROPOSAL FOR PUBLIC  
DECLARATION (DENUNCIATION) OF BTTR.

BACKGROUND:

As you know since the end of 1993, the already mentioned agent has been stating his interest and necessity to return to Cuba due to different personal and family problems which led to the determination of approving to put an end of his mission.

The return proposal to our country of agent German, which was made on March 13 1995, has not been able to be achieved due to different personal and operational problems on his part.

At present, even when he feels a great motivation for his task, he has stated he feels himself pressed by his personal problems with his relatives in Cuba.

In one of the last contacts with him, he stated his wish to definitely return to Cuba before February 26 1996, date of his son's birthday.

Our agent was able to establish since 1992 systematic contacts with Cuban counterrevolutionary pilots, being able to know their plans and intentions, which have timely been reported to the Headquarters.

He periodically flies with BTTR and that's the reason why he has been able to enjoy the confidence of José Basulto, counterrevolutionary leader of BTTR, as well as other pilots and technicians, who have given him information about their aggressive plans against Cuba.

He has accumulated an important informative fund coming from diverse sources or spheres of the counterrevolution, mainly from BTTR, which we can

use for a public declaration or denunciation. Examples of these informations are:

- Jose Basulto's interest in the acquisition of long range weapons for attempts on the Commander in Chief's life.
- The Cuban American National Foundation (CANF) requested German his technical assessment of using arrow-rockets to attempt on the Commander in Chief's life.
- Jose Basulto has communicated his money gathering for attempts on some people's lives in Cuba.
- He has received instructions to interfere the air-traffic control towers in Rancho Boyeros Airport (civilian) and San Antonio de los Baños Airport (military).

MEASURES PROPOSED AGAINST THE COUNTERREVOLUTIONARY ACTIVITIES OF BTTR.

We have evaluated the convenience of carrying out an operation to neutralize the counterrevolutionary actions of BTTR.

Operation "Venecia" consists in returning him to Cuba and carrying out a well documented public declaration or denunciation about their counterrevolutionary plans.

The aim we pursue is to call the attention of the national and international public opinion in order to:

- Accuse BTTR in their counterrevolutionary activities and violation of our sovereignty and international law.

- Create uncertainty within the counterrevolution and terrorist groups.
- We will study and propose different variants for German's return, which will be sent for your approval.

Once in Cuba, we will report and describe in details the way and methods to use in carrying out this declaration or denunciation, which can be done at the end of February or beginning of March 1996.
