1. AT TWO RECENT MEETINGS, ONE WITH [REDACTED] ONE WITH [REDACTED] MADE A VARIETY OF ADMISSIONS - FULL DETAILS OF THE MEETINGS AND THE ADMISSIONS FOLLOW BY LETTER. ENCAPSULATED THE ADMISSIONS AMOUNT TO THE FOLLOWING:

2. [REDACTED] SOME CONSIDERABLE TIME AGO (1966) HAD A SEXUAL RELATIONSHIP WITH MCGRATH WHO IS OF COURSE CURRENTLY ACCUSED OF HOMOSEXUAL RELATED CRIMES. ALTHOUGH THIS RELATIONSHIP (AND ONE OTHER WITH A THIRD UNNAMED PERSON WHICH WAS ADMITTED) WAS NOT SUCH THAT WOULD ATTRACT THE FULL ODIUM OF THE LAW IF TELLING THE TRUTH), CLEARLY [REDACTED] IS AWARE OF THE VULNERABILITY OF HIS POSITION. AT LEAST THE TWO OTHER WELL KNOWN POLITICIANS ARE AWARE OF THE [REDACTED] MCGRATH RELATIONSHIP SINCE MCGRATH HAD TOLD THEM. THE IMMINENT ARREST OF [REDACTED] (OUR TUR) WILL HEIGHTEN THIS AWARENESS WE FEEL.

3. [REDACTED] ALSO REVEALED SOME TIME AGO (1976) TO MCGRATH THAT HE WAS IN CONTACT WITH THE QUOTE SECURITY FORCES UNQUOTE. THE REVELATION WAS MADE IN SUCH A WAY THAT MCGRATH WILL HAVE ASSUMED THE CONTACT NOT TO BE A TRANSIENT ONE. MCGRATH NEVER FERRERED TO THIS ADMISSION BUT CLEARLY WE CANNOT BE SURE THAT HE HAS KEPT THE INFORMATION TO HIMSELF. WE HAVE THEREFORE REVIEWED OUR RELATIONSHIP WITH [REDACTED]
