HORRIBLE DETAILS.

The following letter from a recent emigrant to the State of Mississippi, we find in the Charleston Courier. 'TRENCHARD, Madison County, Mississippi. Before this reaches you, no doubt you will have heard through the newspapers, that the citizens of this and the adjoining counties have been, since the 26th of July, the most cruel and atrocious persecution and excitement up to the present time, and as I have been an eye witness to most of the proceedings, and incident to the late black rebellion in the village of Livingston, I will detail them for your information. On the 29th of June, a conversation was overheard by two gentlemen between some negroes in an intemperate manner. Information was immediately extended to the citizens, and an express sent to the adjoining county. The citizens of Madison, on the 30th of June, held a meeting at Livingston to concert together. Upon examination of the report, it was deemed alarming, and two negroes were examined on the 1st of July—two being belonging to Ruel Blake, and the other to William Johnson—but the evidence being insufficient to satisfy the people of their guilt, they remained in prison for further examination. On the 2d, many of the citizens becoming sensible of the great danger and guilt of the two who were first examined, seized and hung them without further delay, they confessing that white men were the leaders and instigators of the plot. Forthwith a committee of thirteen of the most respectable citizens was organized, and invested with full authority (extending to life over black and white) to try, condemn, and execute all suspicious persons brought before them, and the citizens unanimously pledged themselves to support the committee in all their acts. The committee was composed of Dr. James Grant, James H. Spenser, Wm. Wards, Nelson Taylor, Harwood D. Reynolds, John Simons, Jesse Maybrake, Charles Smith, Robert Hodge, Thomas Hamilton, and Dr. Daniel Smith. The first two white men brought before the committee were Drs. Joshua Cotton and Saunders (Steam Doctors) who were on the 4th of July convicted and executed. Cotton confessed (not under the gallows, for there was none, and they were hanged at the side of an old jail, suspended from the grating of the State Prison, and executed the next night. Parties of horsemen were detached to arrest many white men and negroes, and until the present day, were in constant pursuit of any and night arriving at Livingston with prisoners. On the 6th, Gregory, aged 72 years, was sentenced to 150 lashes, and to leave the State in 48 hours. This is called a whipping, and is performed in the following manner: The prisoner is stripped naked, and on his belly, his hands and feet fastened to four posts, with a clematis he receives the stripes from different hands, and is whipped until he is almost insensible. His back was literally fayed, Lee Smith was ordered out of the State in 48 hours, but was afterwards arrested by his neighbors, and taken to the State Prison, where he was observed by one of the committee, had not been sufficient soon, he would have been hung, as against him. A more white man, Dean of Connecticut, and Donovan of Kentucky, were convicted, and on the 8th, expelled their crimes under a rule which existed in the center of the village. Mitchell, a blacksmith, was entirely acquitted, and his services as a smith held in requisition. He was the happiest man on the hill, retaining every service required with the utmost promptness and cheerfulness. Holden was also acquitted. Hiram H. Perkins, and another man, were ordered to 150 lashes, and to leave the State in 48 hours, or to receive 500 lashes, and not to return under penalty of death; (of course they trumpeted and they did not go).
