LETTER FROM THE CHAIRMAN

Dear Fellow Conservative.

The American Conservative Union Foundation is proud to present our ratings of the 2018 meeting of the California State Legislature. Like our *Ratings of Congress*, which date back 47 years, our state ratings are meant to reflect how elected officials view the role of government in an individual's life. We begin with our philosophy i.e., conservatism is the political philosophy that sovereignty resides in the person, and then apply our understanding of government (its essential role is to defend Life, Liberty and Property).

Because our ratings are designed to educate the public about how consistently elected officials adhere to conservatism, we carefully examine the entire docket of legislation introduced in each state every year. We select the most meaningful bills and publish the results after the dust has settled. ACUF state ratings—launched in 2011 with ratings for five states—have become a nationally recognized resource for evaluating over 8,000 elected officials comprising each of America's 99 state legislative chambers.

Each election cycle, citizens choose leaders whose vision for the state most closely matches their own, hoping that candidates' promises will be kept. ACUF's ratings measure whether those promises were fulfilled or forsaken. With nearly a decade of data on state legislators' voting records and average scores for every legislative chamber, citizens in every state can assess how effectively their lawmakers have applied conservative philosophy to the role of government.

We at ACUF believe, as Ronald Reagan once said, that freedom is never more than one generation away from extinction. We hope that by providing this unique tool, these ratings will empower Americans to exercise their right to protect our unique American democracy from tyranny.

ACU researched and selected a range of bills before the California State Legislature that determine a member's adherence to conservative principles. We selected bills that focus on Ronald Reagan's philosophy of the "three-legged stool": 1) fiscal and economic: taxes, budgets, regulation, spending, healthcare, and property; 2) social and cultural: 2nd amendment, religion, life, welfare, and education; and 3) government integrity: voting, individual liberty, privacy, and transparency. This wide range of issues are designed to give citizens an accurate assessment that conveys which of California's elected leaders best defend the principles of a free society: Life, Liberty and Property.





CALIFORNIA SENATE CONSERVATIVE RATINGS







CALIFORNIA SENATE VOTE DESCRIPTIONS

- 1. AB 1407 Expanding Automatic Voter Registration. This bill further expands the state's automatic motor voter registration system to now "pre-register" children ages 16 and 17 to vote when they visit the Department of Motor Vehicles. ACU opposes automatic registration programs which weaken ballot integrity and makes it easier to commit voter fraud and opposed this bill. The Senate passed the bill on February 8, 2018 by a vote of 25-12.
- 2. SB 1171 Establishing Same-Day Voter Registration. This bill permits individuals to both register and vote on the same day. ACU opposes same-day voter registration, which prevents the state from verifying applicant qualifications and invites increased voter fraud, and opposed this bill. The Senate passed the bill on April 5, 2018 by a vote of 25-10.
- 3. SB 974 Expanding Medicaid Coverage to Illegal Immigrants Ages 65 and Older. This bill expands California's Medicaid program, known as Medical, to illegal immigrants ages 65 and older. The bill provides full-scope health benefits and is expected to cost over \$220 million per year. ACU opposes further expanding a program rife with fraud and abuse, especially to those residing in the country illegally, and opposed this bill. The Senate passed the bill on May 30, 2018 by a vote of 21-12.
- 4. AB 406 Reducing School Choice by Banning For-Profit Charter Schools. This bill reduces school choice by prohibiting charter school from operating or being operated by a for-profit organization after July 1, 2019. ACU supports expanding parents' education options for their children and opposes this attack on school choice and our free-enterprise system and opposed this bill. The Senate passed the bill on July 2, 2018 by a vote of 28-7.
- 5. SB 969 Forcing Homeowners to Install Battery Backups for their Garage Door Opener Systems. This bill mandates that all automatic garage door opener systems manufactured or sold in the state include a battery backup system that will allow the opener to operate during a power outage. Additionally, the bill makes it unlawful (subject to a \$1,000 fine) for anyone to install an opener, or a garage door to an opener, that does not contain a battery backup system. ACU believes homeowners should be able to access their properties by the system of their choice, opposes this mandate which will drastically drive up consumer costs, and opposed this bill. The Senate passed the bill on August 20, 2018 by a vote of 37-0.

- 6. SB 910 Banning Short-Term Low-Cost Health Care Plans. This bill bans health insurers from offering short-term, limited duration health care plans, which are much less expensive than traditional plans as they are not required to cover the "essential health benefits" mandated under Obamacare. ACU has long opposed Obamacare, which has led to skyrocketing health care costs, and opposes this ban which prevents individuals from obtaining truly affordable health care by choosing the plan that best fits their needs and opposed this bill. The Senate passed the bill on August 20, 2018 by a vote of 27-9.
- 7. AB 1884 Mandating Restaurants Keep Plastic Straws "Under the Counter." This bill prohibits restaurants from providing a single-use plastic straw to a consumer unless requested by the consumer. Restaurants caught violating this mandate are fined \$25 for each day the violation occurs. ACU opposes this government intrusion in the private sector which needlessly drives up business costs in order to advance a politicized climate change agenda and opposed this bill. The Senate passed the bill on August 20, 2018 by a vote of 27-12.
- 8. AB 2103 Increasing Barriers to Obtain a Concealed Carry Permit. This bill places unnecessary burdens on individuals wishing to obtain a concealed carry permit. The bill mandates the training course to obtain the permit to include a minimum of eight hours of instruction as well as live-fire shooting exercises on a firing range. ACU supports the founders' belief in the Second Amendment and opposes these burdensome and expensive requirements that are primarily designed to discourage individuals from obtaining permits and opposed this bill. The Senate passed the bill on August 21, 2018 by a vote of 28-9.
- 9. SB 1192 Dictating Children's Beverage Offerings of Restaurants. This bill forces all restaurants that serve children's meals to make the default beverage provided water, milk (unflavored), or a nondairy milk alternative. Restaurants that offer soda without a customer's specific request can be fined up to \$500 for each violation. ACU opposes this attack on parental rights and needless burden on restaurants and opposed this bill. The Senate passed the bill on August 21, 2018 by a vote of 29-9.



- 10. AB 1895 Expanding a Student Loan Program for Illegal Immigrants. This bill places taxpayer funds at further risk by expanding a loan program for illegal immigrants to include an "income-based repayment plan," which allows borrowers to delay their repayments. ACU opposes providing education funding to those residing in the country illegally and placing taxpayer funds at higher risks of default and opposed this bill. The Senate passed the bill on August 21, 2018 by a vote of 31-5.
- 11. SB 174 Permitting Illegal Immigrants to Serve on State Boards and Commissions. This bill allows those residing illegally in the country to serve on any appointed state or local board or commission. ACU opposes granting noncitizens ruling authority over American citizens, supports assisting the federal government to perform its constitutional role to enforce the nation's immigration laws, and opposed this bill. The Senate passed the bill on August 24, 2018 by a vote of 26-11.
- 12. AB 2455 Providing Labor Unions Access to Personal Information Collected by the State. This bill requires the Department of Social Services to turn over to labor unions the personal information (including home and cellphone numbers) of new home care aides that register with the state. ACU opposes subjecting home aides to harassment by union organizers and this abuse of government power and opposed this bill. The Senate passed the bill on August 24, 2018 by a vote of 23-14.
- 13. AB 1870 Increasing Frivolous Litigation by Extending the Deadline for Filing Employer Complaints. This bill triples the time period (from one year to three years) in which an employee may file a complaint with the Department of Fair Employment and Housing alleging employment discrimination. Employment discrimination is wrong, and no one should suffer discrimination in their job. ACU believes that the one-year limitation previously enacted by the California State Legislature struck a good balance between protecting employee rights and protecting employers from frivolous lawsuits. ACU opposes inviting frivolous lawsuits, which reduces employment and drives up the cost of goods and services, and opposed this bill. The Senate passed the bill on August 27, 2018 by a vote of 25-10.

- 14. AB 2888 Expanding the Seizure of Firearms without Due Process. This bill expands an existing law to allow employers, co-workers and school employees to file ex parte (i.e., one-sided) petitions to a court for the issuance of a "gun violence restraining order." Under the bill, a court may order the temporary seizure of all firearms held by an individual if they are considered to be a danger to themselves or others simply due to their possession of a firearm. ACU supports the founders' belief in the Second Amendment, opposes the seizure of firearms without due process and on the basis of unchallenged accusations and opposed this bill. The Senate passed the bill on August 28, 2018 by a vote of 25-12.
- 15. AB 2138 Reducing Barriers for those with Criminal Convictions by Reforming Occupational Licensure. This bill is designed to expand employment and reduce recidivism by reforming provisions of the state's occupational licensing system that relate to those with criminal convictions. Under the bill, licensing boards are only able to deny a license if the individual's conviction is "substantially related" to the licensed occupation. Furthermore, convictions older than seven years cannot be considered unless they are certain serious felonies or financial crimes. ACU Foundation's Center for Criminal Justice Reform is a leading authority on this issue, and works to improve public safety, reduce costs and lower recidivism. ACU opposes the proliferation of licensing requirements and supports this effort to expand job growth and reduce recidivism by reducing barriers to employment and supported this bill. The Senate passed the bill on August 28, 2018 by a vote of 24-13.
- 16. SB 1288 Increasing Hospital Penalties for Minor Violations to Benefit Unions. This bill is an attempt by the Service Employees International Union (SEIU) to pressure hospitals to hire additional union workers. The bill mandates the state's Department of Public Health (DPH) to conduct unannounced inspections of nurse-to-patient ratios in hospitals and forces the DPH to impose fines of \$15,000 or more for any violation. Under previous law, the DPH is only authorized to impose fines for more severe violations, such as ones constituting an "immediate jeopardy." Additionally, the DPH had full discretion to take all circumstances into account when imposing a penalty. ACU opposes driving up health care costs solely to benefit the greed of the SEIU and opposed this bill. The Senate passed the bill on August 29, 2018 by a vote of 25-14 but it was vetoed by the governor.



- 17. SB 100 Raising Energy Costs by Increasing the "Renewable" Energy Mandate. This bill raises electricity costs by increasing the Renewables Portfolio Standard from 50 to 60 percent by the year 2030. The Renewables Portfolio Standard forces utility companies to obtain at least 60 percent of their energy from "renewable" resources. By the year 2045, 100 percent of the retail electricity supply is required to come renewable and zero-carbon resources. ACU supports all forms of energy, believes government should not support one form of energy over another, opposes this mandate which places significant costs on ratepayers, and opposed this bill. The Senate passed the bill on August 29, 2018 by a vote of 25-13.
- 18. AB 2079 Burdening Businesses with Additional Mandates that Benefit Special Interests. This bill is designed to enrich certain organizations by amending a law passed in 2016 that mandates ignitorial businesses provide sexual harassment prevention training to their employees. Under the bill, janitorial businesses are forced to contract only with "qualified organizations" to train their employees on sexual harassment prevention. Under the bill, organizations are only "qualified" if they have been in business for at least five years, have at least 100 qualified educators, pay educators at least twice the minimum wage (\$30 per hour in some parts of the state), and conform to numerous other regulations solely designed to limit competition and drive up profits. ACU believes sexual harassment is a serious problem, but we oppose mandated training which drives up business and consumer costs and find it absurd to hold businesses hostage to only select training providers, and opposed this bill. The Senate passed the bill on August 29. 2018 by a vote of 26-11 but it was vetoed by the governor.
- 19. SB 1100 Raising the Minimum Age to 21 to Purchase All Firearms. This bill infringes on Second Amendment rights by raising the minimum age to purchase a long gun from 18 to 21 years (the minimum age to purchase a hand gun is already 21 years). ACU supports the founders' belief in the Second Amendment and believes those old enough to fight for their country should not be deprived of their constitutional right to carry arms and opposed this bill. The Senate passed the bill on August 29, 2018 by a vote of 26-12.

- 20. SB 834 Blocking Offshore Oil and Gas Production. This bill is designed to hinder oil and gas production in federal waters by preventing the California State Lands Commission from approving, extending, or modifying any pipelines or infrastructure in the roughly three-mile area off the coast that is controlled by the state. ACU supports the production of all forms of energy and opposes this attack on the Trump Administration's effort to reduce energy costs and expand economic growth and opposed this bill. The Senate passed the bill on August 29, 2018 by a vote of 28-7.
- 21. AB 1080 Driving up State Public Works Project Costs. This bill drives up taxpayer costs by providing a 5 percent bid preference on state public works projects to contractors who provide their employees with health care coverage. ACU believes employers and employees should be free to negotiate their own benefits and opposes burdening taxpayers with unnecessary additional costs and opposed this bill. The Senate passed the bill on August 30, 2018 by a vote of 28-10 but it was vetoed by the governor.
- 22. SB 320 Requiring the Sale of Abortion-Inducing Drugs on College Campuses. This bill mandates that by January of 2022, all public university student health centers offer abortion by medication, including the abortion pills mifepristone and misoprostol. Furthermore, the bill establishes a fund comprising federal and private moneys which is to be used for "medical abortion readiness" at the colleges. ACU believes abortion is a human tragedy, supports restrictions on the practice and opposed this bill. The Senate passed the bill on August 30, 2018 by a vote of 26-13 but it was vetoed by the governor.
- 23. SB 700 Extending and Increasing a Tax on Utility Ratepayers to Fund Renewable Energy. This bill extends and increases the Self-Generation Incentive Program (SGIP) which raises utility rates on all consumers in order to subsidize solar energy users who install "energy storage systems" which store the excess solar energy they generate. Under the bill, the SGIP is extended through the year 2025, and utility companies are authorized to collect up to \$166 million per year from ratepayers in order to pay for the subsidies. ACU supports all forms of energy, believes government should not support one form of energy over another and opposed this bill. The Senate passed the bill on August 30, 2018 by a vote of 25-12



- 24. SB 826 Interfering in Private-Sector Business Operations by Mandating Gender Quotas. This bill mandates that all publicly traded corporations headquartered in the state include at least one female on their board of directors by the end of 2019, and by 2021, have at least three female directors if the board contains six or more members. Under the bill, corporations that fail to comply with the mandate, or fail to file board member information with the state, are fined up to \$300,000 per offense. ACU opposes this interference in the private sector, acknowledges the "fatal" legal problems identified by Governor Brown and opposed this bill. The Senate passed the bill on August 30, 2018 by a vote of 23-9.
- 25. SB 1376 Socializing Rideshare Services by Imposing a 5 Cent Tax on All Rides. This bill requires the California Public Utilities Commission to impose a tax of at least 5 cents on every ride provided by a transportation network company such as Uber or Lyft. The funds are then to be used to subsidize the rides of individuals who require a wheelchair accessible vehicle. While ACU sympathizes with those who require such services, we oppose driving up ride sharing costs for everyone, especially when the state and localities already provide myriad transportation services for those with disabilities, and opposed this bill. The Senate passed the bill on August 30, 2018 by a vote of 30-8.
- 26. SB 1487 Banning the Possession and Transfer of African Animal Trophies. This bill places endangered African species at further risk by preventing the possession, sale or transfer of most African animal trophies (including body components and carcasses). While individuals who possess animal trophies prior to January 1, 2019 are allowed to keep their property, the bill prevents these individuals from ever selling or transferring their property. ACU supports helping endangered species thrive, opposes this economically ignorant measure that infringes on property rights and prevents the market from allocating the supply of existing deceased animal components, thus creating increased demand for new hunting, and opposed this bill. The Senate passed the ill on August 31, 2018 by a vote of 27-11.

- 27. SB 1172 Reducing Transparency and Weakening Protections against Abuses of Eminent Domain. This bill weakens property rights and reduces government transparency in an effort to advance the California High-Speed Rail Project, a boondoggle which was authorized in 2008 at a cost of \$35 billion and has since ballooned to over \$77 billion with an estimated completion date in excess of 30 years. Under the bill, the High-Speed Rail Authority (HSRA) will be provided with numerous expanded powers, including control of eminent domain proceedings (with reduced protections for property owners) and exclusive control of the HSRA by removing oversight from other governmental entities. ACU Foundation's Center for 21st Century Property Rights is a leading voice on eminent domain and believes property should only be taken for public purposes, with vigilant oversight, and with just compensation for property owners. ACU opposes weakening property rights and reducing oversight of a project that has been completely derailed by repeated mismanagement and opposed this bill. The Senate passed the bill on August 31, 2018 by a vote of 25-13.
- 28. SB 822 Reinstating "Net Neutrality" and Interference and Regulation of the Internet. This bill is designed to reinstate Obama-era regulations of Internet Service Providers (ISPs) that were overturned by Ajit Pai and the FCC. These regulations, commonly referred to as "net neutrality," are price controls that prohibit ISPs from charging different rates for faster service or blocking websites. Additionally, the bill bans "zero-rating agreements" that exempt particular data from counting against a user's data cap. ACU supports an internet free of government interference, which has allowed it to thrive since its conception, and opposes heavy-handed government regulations, such as net neutrality, which have favored some companies while placing over 1,000 small ISPs at a disadvantage, and opposed this bill. The Senate passed the bill on August 31, 2018 by a vote of 27-12.







CALIFORNIA ASSEMBLY VOTE DESCRIPTIONS

- 1. AB 1407 Expanding Automatic Voter Registration. This bill further expands the state's automatic motor voter registration system to now "pre-register" children ages 16 and 17 to vote when they visit the Department of Motor Vehicles. ACU opposes automatic registration programs which weaken ballot integrity and makes it easier to commit voter fraud and opposed this bill. The Assembly passed the bill on February 20, 2018 by a vote of 46-22.
- 2. AB 2888 Expanding the Seizure of Firearms without Due Process. This bill expands an existing law to allow employers, co-workers and school employees to file ex parte (i.e., one-sided) petitions to a court for the issuance of a "gun violence restraining order." Under the bill, a court may order the temporary seizure of all firearms held by an individual if they are considered to be a danger to themselves or others simply due to their possession of a firearm. ACU supports the founders' belief in the Second Amendment, opposes the seizure of firearms without due process and on the basis of unchallenged accusations and opposed this bill. The Assembly passed the bill on May 21, 2018 by a vote of 48-25.
- 3. AB 2965 Expanding Medicaid Coverage to Illegal Immigrants Age 26 and Younger. This bill expands California's Medicaid program, known as Medi-Cal, to illegal immigrants ages 26 and younger. The bill provides full-scope health benefits and is expected to cost over \$400 million per year. ACU opposes further expanding a program rife with fraud and abuse, especially to those residing in the country illegally, and opposed this bill. The Assembly passed the bill on May 30, 2018 by a vote of 47-25.
- 4. SB 1171 Establishing Same-Day Voter Registration. This bill permits individuals to both register and vote on the same day. ACU opposes same-day voter registration, which prevents the state from verifying applicant qualifications and invites increased voter fraud, and opposed this bill. The Assembly passed the bill on June 28, 2018 by a vote of 53-23.

- 5. SB 910 Banning Short-Term Low-Cost Health Care Plans. This bill bans health insurers from offering short-term, limited duration health care plans, which are much less expensive than traditional plans as they are not required to cover the "essential health benefits" mandated under Obamacare. ACU has long opposed Obamacare, which has led to skyrocketing health care costs, and opposes this ban which prevents individuals from obtaining truly affordable health care by choosing the plan that best fits their needs and opposed this bill. The Assembly passed the bill on August 16, 2018 by a vote of 51-21.
- 6. SB 969 Forcing Homeowners to Install Battery Backups for their Garage Door Opener Systems. This bill mandates that all automatic garage door opener systems manufactured or sold in the state include a battery backup system that will allow the opener to operate during a power outage. Additionally, the bill makes it unlawful (subject to a \$1,000 fine) for anyone to install an opener, or a garage door to an opener, that does not contain a battery backup system. ACU believes homeowners should be able to access their properties by the system of their choice, opposes this mandate which will drastically drive up consumer costs, and opposed this bill. The Assembly passed the bill on August 16, 2018 by a vote of 64-7.
- 7. SB 1192 Dictating Children's Beverage Offerings of Restaurants. This bill forces all restaurants that serve children's meals to make the default beverage provided water, milk (unflavored), or a nondairy milk alternative. Restaurants that offer soda without a customer's specific request can be fined up to \$500 for each violation. ACU opposes this attack on parental rights and needless burden on restaurants and opposed this bill. The Assembly passed the bill on August 16, 2018 by a vote of 46-26.
- 8. SB 174 Permitting Illegal Immigrants to Serve on State Boards and Commissions. This bill allows those residing illegally in the country to serve on any appointed state or local board or commission. ACU opposes granting noncitizens ruling authority over American citizens, supports assisting the federal government to perform its constitutional role to enforce the nation's immigration laws, and opposed this bill. The Assembly passed the bill on August 20, 2018 by a vote of 46-26.



- 9. AB 406 Reducing School Choice by Banning For-Profit Charter Schools. This bill reduces school choice by prohibiting charter school from operating or being operated by a for-profit organization after July 1, 2019. ACU supports expanding parents' education options for their children and opposes this attack on school choice and our free-enterprise system and opposed this bill. The Assembly passed the bill on August 23, 2018 by a vote of 60-16.
- 10. AB 1884 Mandating Restaurants Keep Plastic Straws "Under the Counter." This bill prohibits restaurants from providing a single-use plastic straw to a consumer unless requested by the consumer. Restaurants caught violating this mandate are fined \$25 for each day the violation occurs. ACU opposes this government intrusion in the private sector which needlessly drives up business costs in order to advance a politicized environmental agenda and opposed this bill. The Assembly passed the bill on August 23, 2018 by a vote of 50-25.
- 11. AB 2103 Increasing Barriers to Obtain a Concealed Carry Permit. This bill places unnecessary burdens on individuals wishing to obtain a concealed carry permit. The bill mandates the training course to obtain the permit to include a minimum of eight hours of instruction as well as live-fire shooting exercises on a firing range. ACU supports the founders' belief in the Second Amendment and opposes these burdensome and expensive requirements that are primarily designed to discourage individuals from obtaining permits and opposed this bill. The Assembly passed the bill on August 27, 2018 by a vote of 61-16.
- 12. AB 1895 Expanding a Student Loan Program for Illegal Immigrants. This bill places taxpayer funds at further risk by expanding a loan program for illegal immigrants to include an "income-based repayment plan," which allows borrowers to delay their repayments. ACU opposes providing education funding to those residing in the country illegally and placing taxpayer funds at higher risks of default and opposed this bill. The Assembly passed the bill on August 27, 2018 by a vote of 63-4.
- 13. SB 834 Blocking Offshore Oil and Gas Production. This bill is designed to hinder oil and gas production in federal waters by preventing the California State Lands Commission from approving, extending, or modifying any pipelines or infrastructure in the roughly three-mile area off the coast that is controlled by the state. ACU supports the production of all forms of energy and opposes this attack on the Trump Administration's effort to reduce energy costs and expand economic growth and opposed this bill. The Assembly passed the bill on August 27, 2018 by a vote of 45-25.

- 14. SB 1288 Increasing Hospital Penalties for Minor Violations to Benefit Unions. This bill is an attempt by the Service Employees International Union (SEIU) to pressure hospitals to hire additional union workers. The bill mandates the state's Department of Public Health (DPH) to conduct unannounced inspections of nurse-to-patient ratios in hospitals and forces the DPH to impose fines of \$15,000 or more for any violation. Under previous law, the DPH is only authorized to impose fines for more severe violations, such as ones constituting an "immediate jeopardy." Additionally, the DPH had full discretion to take all circumstances into account when imposing a penalty. ACU opposes driving up health care costs solely to benefit the greed of the SEIU and opposed this bill. The Assembly passed the bill on August 28, 2018 by a vote of 49-26 but it was vetoed by the governor.
- 15. SB 100 Raising Energy Costs by Increasing the "Renewable" Energy Mandate. This bill raises electricity costs by increasing the Renewables Portfolio Standard from 50 to 60 percent by the year 2030. The Renewables Portfolio Standard forces utility companies to obtain at least 60 percent of their energy from "renewable" resources. By the year 2045, 100 percent of the retail electricity supply is required to come from renewable and zero-carbon resources. ACU supports all forms of energy, believes government should not support one form of energy over another, opposes this mandate which places significant costs on ratepayers, and opposed this bill. The Assembly passed the bill on August 28, 2018 by a vote of 44-33.
- 16. SB 1100 Raising the Minimum Age to 21 to Purchase All Firearms. This bill infringes on Second Amendment rights by raising the minimum age to purchase a long gun from 18 to 21 years (the minimum age to purchase a hand gun is already 21 years). ACU supports the founders' belief in the Second Amendment and believes those old enough to fight for their country should not be deprived of their constitutional right to carry arms and opposed this bill. The Assembly passed the bill on August 28, 2018 by a vote of 47-30.



- 17. SB 1376 Socializing Rideshare Services by Imposing a 5 Cent Tax on All Rides. This bill requires the California Public Utilities Commission to impose a tax of at least 5 cents on every ride provided by a transportation network company such as Uber or Lyft. The funds are then to be used to subsidize the rides of individuals who require a wheelchair accessible vehicle. While ACU sympathizes with those who require such services, we oppose driving up ride sharing costs for everyone, especially when the state and localities already provide myriad transportation services for those with disabilities, and opposed this bill. The Assembly passed the bill on August 28, 2018 by a vote of 56-13.
- 18. SB 320 Requiring the Sale of Abortion-Inducing Drugs on College Campuses. This bill mandates that by January of 2022, all public university student health centers offer abortion by medication, including the abortion pills mifepristone and misoprostol. Furthermore, the bill establishes a fund comprising federal and private moneys which is to be used for "medical abortion readiness" at the colleges. ACU believes abortion is a human tragedy, supports restrictions on the practice and opposed this bill. The Assembly passed the bill on August 29, 2018 by a vote of 52-25 but it was vetoed by the governor.
- 19. AB 1870 Increasing Frivolous Litigation by Extending the Deadline for Filing Employer Complaints. This bill triples the time period (from one year to three years) in which an employee may file a complaint with the Department of Fair Employment and Housing alleging employment discrimination. Employment discrimination is wrong, and no one should suffer discrimination in their job. ACU believes that the one-year limitation previously enacted by the California State Legislature struck a good balance between protecting employee rights and protecting employers from frivolous lawsuits. ACU opposes inviting frivolous lawsuits, which reduces employment and drives up the cost of goods and services, and opposed this bill. The Assembly passed the bill on August 29, 2018 by a vote of 61-9.

- 20. SB 826 Interfering in Private-Sector Business Operations by Mandating Gender Quotas. This bill mandates that all publicly traded corporations headquartered in the state include at least one female on their board of directors by the end of 2019, and by 2021, have at least three female directors if the board contains six or more members. Under the bill, corporations that fail to comply with the mandate, or fail to file board member information with the state, are fined up to \$300,000 per offense. ACU opposes this interference in the private sector, acknowledges the "fatal" legal problems identified by Governor Brown and opposed this bill. The Assembly passed the bill on August 29, 2018 by a vote of 41-26.
- 21. SB 700 Extending and Increasing a Tax on Utility Ratepayers to Fund Renewable Energy. This bill extends and increases the Self-Generation Incentive Program (SGIP) which raises utility rates on all consumers in order to subsidize solar energy users who install "energy storage systems" which store the excess solar energy they generate. Under the bill, the SGIP is extended through the year 2025, and utility companies are authorized to collect up to \$166 million per year from ratepayers in order to pay for the subsidies. ACU supports all forms of energy, believes government should not support one form of energy over another and opposed this bill. The Assembly passed the bill on August 29, 2018 by a vote of 57-18.
- 22. AB 2455 Providing Labor Unions Access to Personal Information Collected by the State. This bill requires the Department of Social Services to turn over to labor unions the personal information (including home and cellphone numbers) of new home care aides that register with the state. ACU opposes subjecting home aides to harassment by union organizers and this abuse of government power and opposed this bill. The Assembly passed the bill on August 29, 2018 by a vote of 47-26 but it was vetoed by the governor.



- 23. AB 2079 Burdening Businesses with Additional Mandates that Benefit Special Interests. This bill is designed to enrich certain organizations by amending a law passed in 2016 that mandates janitorial businesses provide sexual harassment prevention training to their employees. Under the bill, janitorial businesses are forced to contract only with "qualified organizations" to train their employees on sexual harassment prevention. Under the bill, organizations are only "qualified" if they have been in business for at least five years, have at least 100 qualified educators, pay educators at least twice the minimum wage (\$30 per hour in some parts of the state), and conform to numerous other regulations solely designed to limit competition and drive up profits. ACU believes sexual harassment is a serious problem, but we oppose mandated training which drives up business and consumer costs and find it absurd to hold businesses hostage to only select training providers, and opposed this bill. The Assembly passed the bill on August 30, 2018 by a vote of 52-26 but it was vetoed by the governor.
- 24. AB 1080 Driving up State Public Works Project Costs. This bill drives up taxpayer costs by providing a 5 percent bid preference on state public works projects to contractors who provide their employees with health care coverage. ACU believes employers and employees should be free to negotiate their own benefits and opposes burdening taxpayers with unnecessary additional costs and opposed this bill. The Assembly passed the bill on August 30, 2018 by a vote of 61-19 but it was vetoed by the governor.
- 25. SB 1172 Reducing Transparency and Weakening Protections against Abuses of Eminent Domain. This bill weakens property rights and reduces government transparency in an effort to advance the California High-Speed Rail Project, a boondoggle which was authorized in 2008 at a cost of \$35 billion and has since ballooned to over \$77 billion with an estimated completion date in excess of 30 years. Under the bill. the High-Speed Rail Authority (HSRA) will be provided with numerous expanded powers, including control of eminent domain proceedings (with reduced protections for property owners) and exclusive control of the HSRA by removing oversight from other governmental entities. ACU Foundation's Center for 21st Century Property Rights is a leading voice on eminent domain and believes property should only be taken for public purposes, with vigilant oversight, and with just compensation for property owners. ACU opposes weakening property rights and reducing oversight of a project that has been completely derailed by repeated mismanagement and opposed this bill. The Assembly passed the bill on August 30, 2018 by a vote of 46-29.

- 26. AB 2138 Reducing Barriers for those with Criminal Convictions by Reforming Occupational Licensure. This bill is designed to expand employment and reduce recidivism by reforming provisions of the state's occupational licensing system that relate to those with criminal convictions. Under the bill, licensing boards are only able to deny a license if the individual's conviction is "substantially related" to the licensed occupation. Furthermore, convictions older than seven years cannot be considered unless they are certain serious felonies or financial crimes. ACU Foundation's Center for Criminal Justice Reform is a leading authority on this issue, and works to improve public safety, reduce costs and lower recidivism. ACU opposes the proliferation of licensing requirements and supports this effort to expand job growth and reduce recidivism by reducing barriers to employment and supported this bill. The Assembly passed the bill on August 30, 2018 by a vote of 47-29.
- 27. SB 822 Reinstating "Net Neutrality" and Interference and Regulation of the Internet. This bill is designed to reinstate Obama-era regulations of Internet Service Providers (ISPs) that were overturned by Ajit Pai and the FCC. These regulations, commonly referred to as "net neutrality," are price controls that prohibit ISPs from charging different rates for faster service or blocking websites. Additionally, the bill bans "zero-rating agreements" that exempt particular data from counting against a user's data cap. ACU supports an internet free of government interference, which has allowed it to thrive since its conception, and opposes heavy-handed government regulations, such as net neutrality, which have favored some companies while placing over 1,000 small ISPs at a disadvantage, and opposed this bill. The Assembly passed the bill on August 30, 2018 by a vote of 61-18.
- 28. SB 1487 Banning the Possession and Transfer of African Animal Trophies. This bill places endangered African species at further risk by preventing the possession, sale or transfer of most African animal trophies (including body components and carcasses). While individuals who possess animal trophies prior to January 1, 2019 are allowed to keep their property, the bill prevents these individuals from ever selling or transferring their property. ACU supports helping endangered species thrive, opposes this economically ignorant measure that infringes on property rights and prevents the market from allocating the supply of existing deceased animal components, thus creating increased demand for new hunting, and opposed this bill. The Assembly passed the bill on August 31, 2018 by a vote of 55-20 but it was vetoed by the governor.
