After discussions with a vendor conducting voter registration activity and a recent report
in the Palm Beach Post (Sept. 25, 2012), it has come to our attention that instances of
elections fraud may have occurred in Palm Beach County, relative to voter registration
applications submitted on behalf of
understanding that "elections fraud" includes any irregularities or fraud arising out of or
in connection with voter registration. Rule 1S-2.025, F.A.C. Susan Bucher, the Palm
Beach County Supervisor of Elections, has identified 106 "questionable" applications
submitted by (Strategic Allied Consultants (Strategic) on September 5, 2012
do not know if all of the submitted applications were isolated to a single employee.
but at least one employee has been terminated by the vendor for work conducted in Palm
Beach County.

Further, after additional conversations with the vendor, it appears that similar activity may have occurred in Lee County and an additional employee may have also been terminated. Specifically, the believes that individuals hired by Strategic submitted voter registration forms in these counties which contained false information, or information that was provided by someone other than the voter. For example, in Palm Beach County, some of the submitted applications apparently contain voter signatures falsified by the vendor's employee. In all instances, the questionable applications were for new voter registrations, and for changes to voter's address or party affiliation (which require an application).

Please investigate these allegations pursuant to your authority under section 97.012(15), Florida Statutes.

<u>ELECTIONS FRAUD COMPLAINT - STATEMENT OF FACTS</u> (Supplement to Complaint filed September 27, 2012)

After discussions with Paul Lux, Supervisor of Elections for Okaloosa County, Florida, it appears that there may be additional instances of elections fraud relating to the submission of voter registration applications in certain counties. Such applications were submitted by Strategic Allied Consultants, LLC (Strategic).

According to Mr. Lux, roughly 2600 voter registration applications were submitted to his office from Strategic between August 31 and September 21, 2012. The applications were submitted in eight batches on behalf of voters in Okaloosa and surrounding counties.

Mr. Lux forwarded roughly 450 applications to neighboring Santa Rosa and Walton County for processing. A few applications may have also been forwarded to Escambia County for processing. Of the 2600 applications originally submitted to Okaloosa County, many had various problems ranging from inconsistencies, missing information and perhaps even one deceased voter. For example, Mr. Lux's office received an application that contained nothing more than a person's first name and a street address. Another application contained the name "Robert Johnson" with a street address of "Wexler Street" – the application was signed by "Robert Wexler".

It is understanding that the State Attorney's office has contacted Okaloosa and Santa Rosa County though an investigator. cannot speak to whether any of the other counties involved have been contacted by authorities.
