The emphasis given in contemporary critical thought to the important concepts of difference and identity has meant that less attention has been paid to another concept: collectivity. A key aspect of any politics is the mechanism which brings together and binds individuals into larger groupings; the character of existing collectivities—-nations, ethnicities, political parties, etc.--has been such that recent left thought has seemed to want to either avoid serious theorization of the collective, or has sought to produce theories in which collectivities emerge out of the raw material of individual identities (a tendency from Nancy to Hardt + Negri), thus surreptitiously by-passing the heart of the matter when it comes to thinking about the political.
