# Significant Event Notice: Expense Recovery Fee

#### 30 May 2023

This significant event notice (SEN) is only for members that joined Raiz Invest Super and were issued a Product Disclosure Statement (PDS) dated 28 February 2023.

## What is the change?

**From 1 July 2023** the expense recovery fee of 0.04% p.a. will be calculated on your daily average account balance and will be deducted monthly in arrears directly from your account.

## How will the change affect you?

While the expense recovery fee has not increased, the way it is charged to you has changed from an indirect cost (paid out of the reserves of the fund) to a direct cost. As this fee is charged directly to you, you will see this amount reflected in your transactions.

For example, for a member with an average annual account balance of \$50,000, the expense recovery fee will be approximately \$1.67 per month or \$20.00 per year deducted directly from your account.

This error will only impact members who have received a PDS dated 28 February 2023. The error will not impact any members who have joined Raiz Invest Super and received the PDS dated 16 December 2022 or 15 May 2023 as the expense recovery fee was correctly disclosed in these PDS.

Whilst you are not able to opt out of this change while you are a member of Raiz Invest Super, if the changes outlined in this SEN are not appropriate for your circumstances, you may also consider choosing an alternative super fund.
