Without the predicate domestic violence offense, the City is likewise unable to go forward with Count Two, Interfering with the Reporting of Domestic Violence. In addition, based on the alleged victim's stated intentions for calling 911 at the time of the incident, there is no evidence that the alleged victim was calling 911 to specifically report a domestic violence incident or that the defendant would
