



We have created these visual terms to make your contract with hipages¹ easy for you to use and understand. These terms apply when you post a job and use our platform and app.









### Connecting you with tradies











# Don't pay in full in advance. Every State and Territory has rules about how much a tradie can request as a deposit.

Positive recommendations

Total
(positive + negative & Tradie's rating recommendations)

then the tradie will have a 4.5 star rating

A tradie's star rating represents the proportion of hired connections where the tradie received a recommendation. We only show a star rating for a tradie after the tradie has received feedback from at least 3 hired connections.

If you do not recommend a hired tradie, and this feedback is shared with them, it will impact the tradie's star rating.

#### Positive recommendations

We show positive recommendations on a tradie's profile.


If you have negative feedback on a tradie from a hired connection and you want us to share it with them, we will.

But we are different to a review site and we do not publish negative feedback.

# Account suspension and/or cancellation

#### Why can't I access the hipages platform?

We may suspend you or stop you or others from using the hipages platform. We will usually only do this:

- If we think it's necessary to protect others, our reputation or the integrity of our platform
- · If you breach our terms or break the law
- If your account has been hacked
- If we stop operating the platform

We will try to give you notice, but it may not always be reasonable to do so.



# hipages' limitation of liability

#### Consumer guarantees

You are entitled to certain guarantees under Australian Consumer Law including that our platform services are provided with due care and skill, will be reasonably fit for purpose and will be provided within a reasonable time.



Our platform services relate to connecting you with tradies. But our services do not include the work performed by your chosen tradie.

#### Our limitation of liability

Our liability for any loss or damage suffered by you when using the hipages service is limited to re-providing our platform services or paying for the platform services to be re-provided.

We will not be liable for indirect, incidental or consequential damage or loss arising from your use or inability to use the hipages platform.

#### Entire agreement

These visual terms set out the terms of use for the hipages platform and app. Anything previously discussed about our platform and app has no effect and is replaced by these terms.

#### Changes to these terms

We may need to change these terms from time to time, if this happens, we will let you know at least 30 days before we make the change.


#### **Exclusive programs**
