ON 9-9-10 AT APPROX \_\_\_\_\_ HRS, I OFFICER J WIREY 39218 AND OFFICER B ENGLERT #9351 RESPONDED TO [REDACTED] REFERENCE A DOMESTIC DISTURBANCE.

UPON ARRIVAL MADE CONTACT WITH THE VICTIM JOSIE HARRIS AT THE GUARD GATE. HARRIS STATED SHE HAD BEEN BATTERED BY HER BOYFRIEND FLOYD MAYWEATHER AFTER A VERBAL ARGUMENT. OFFICER HAD JUST RESPONDED TO THE ABOVE ADDRESS AN HOUR PRIOR UNDER EVENT #100905-0464 DUE TO HARRIS AND MAYWEATHER HAVING A VERBAL ARGUMENT.

MAYWEATHER AGREED TO LEAVE AND HARRIS FELL ASLEEP ON THE COUCH. HARRIS AWOKE TO MAYWEATHER OVER HER STRIKING HER IN BACK OF HER HEAD WITH A CLOSED FIST SEVERAL TIMES. MAYWEATHER ALSO PULLED HARRIS HAIR AND TWISTED HER LEFT ARM.

HARRIS STATED SHE WAS PULLED OFF OF THE COUCH BY HER HAIR. DURING THE INCIDENT MAYWEATHER TOLD HARRIS, "I'M GOING TO KILL YOU AND THE MAN YOU ARE MESSING AROUND WITH." HE ALSO STATED "I'M GOING TO GET SOMEONE TO POUR ACID ON YOU." HARRIS YELLED FOR HER CHILDREN TO CALL POLICE. MAYWEATHER THREATENED THEM WITH VIOLENCE IF THEY DID CALL POLICE. THE CHILDREN RAN OUT OF THE HOUSE TOWARDS THE GUARD GATE AT WHICH TIME MAYWEATHER TOLD HIS FRIEND JAMES MCNAIR TO BRING THEM BACK.

MCNAIR RAN AFTER THE CHILDREN AND JOSIE RAN THROUGH THE GARAGE TO THE GUARD SHACK. MAYWEATHER TOLD MCNAIR, "LETS GO". BOTH MEN FLED IN MAYWEATHER'S ROLLS ROYCE OUT THE FRONT GATE.

MEDICAL RESPONDED AND HARRIS WAS TRANSPORTED TO SOUTHERN HILLS HOSPITAL.

HARRIS HAD REDNESS TO HER FACE AND A LARGE CONTUSION TO THE RIGHT SIDE OF HER FOREHEAD AND CHIN.

THE ABOVE INCIDENT WAS WITNESSED BY MAYWEATHER AND HARRIS' CHILD ZION MAYWEATHER WHO IS 9 YEARS OLD.

JOSIE AND ZION BOTH COMPLETED VOLUNTARY STATEMENTS. MAYWEATHER TOOK HARRIS' PHONE DURING THE INCIDENT WHICH IS IN HER NAME.

DV DETECTIVE SCHMIDT #3389 TOO OVER THE FOLLOW UP INVESTIGATION.

I DETECTIVE R. SCHMIDT RESPONDED TO SOUTHERN HILLS HOSPITAL AND CONFRONTED JOSIE HARRIS. THE THREE CHILDREN AND A ROOMATE, GEORGIA "TVA" PARKER WAS ALSO PRESENT.

HARRIS STATED THAT WHEN SHE WAS SLEEPING ON THE COUCH IN THE LIVING ROOM SHE WOKE UP TO FLOYD MAYWEATHER JR STANDING OVER HER YELLING AT HER. HE HAD HER AT&T CELL PHONE, I PHONE 4 CELL # [REDACTED] AND WAS GOING THROUGH HER TEXT MESSAGES.

WHEN HE ASKED IF SHE WAS HAVING SEX WITH "CJ" SHE STATED, "YES I'M SEEING HIM". FLOYD GOT UPSET AND PHYSICALLY ATTACKED JOSIE GRABBING HER HAIR, PULLING HER OFF THE COUCH AND PUNCHING HER. FLOYD JR THEN TOLD A FRIEND THAT WAS PRESENT JAMES MCNAIR, "LETS GO."

FLOYD JR ALSO TOOK WITHOUT PERMISSION JOSIE HARRIS' CEL PHONE AND LEFT WITH THE PHONE. AT THE TIME OF THIS REPORT THE CELL PHONE IS STILL MISSING.

KORAUN MAYWEATHER, 11 YR OLD SON, WITNESSED THE FIGHT AND HIS DAD FLOYD JR PUNCH AND KICK HIS MOTHER JOSIE HARRIS. HE ALSO SAW HIS DAD TAKE HIS MOM'S CELL PHONE AND LEAVE THE HOUSE.

JOSIE HARRIS ALSO STATED HER PURSE WAS MISSING AND COULD NOT BE LOCATED. FRIEND GEORGIA PARKER RECEIVED A PHONE CALL AT 6:26 AM. IT WAS FLOYD JR. HE STATED TO HER TO LEAVE THE HOUSE AND THAT HE HAD JOSIE'S CELL PHONE.

CELL PHONE IS VALUED AT \$322.17 DOLLARS.
