#### Table 1: Testing programme summary

The period under review in this report is 1 October 2011 to 31 December 2011. During this time, the domestic and international Anti-Doping Testing Programme carried out 1,490 missions.

Of the 1490 missions in quarter 3, 212 (14.23%) were attempted under the jurisdiction of an International Federation.

UK Anti-Doping's agreement with the Department for Culture, Media and Sport (DCMS) includes the following key commitment:

Testing is conducted above the following levels:

In Competition (random/placed)	Minimum 30%
Out-of-Competition (random)	Minimum 25%
In Competition/Out-of-Competition (targeted)	Minimum 35%

Testing programme summary missions, by test type: quarter 3; 2011–12




Table 3: Possible Anti-Doping Rule Violations – Summary of category of substance (closed cases, reported in the past 12 months)
