The period under review in this report is 1 January–31 March 2010. During this time, the domestic and international Anti-Doping Testing Programme carried out 2,209 missions.


Of the 2,211 missions in quarter 4, 194 (8.8%) were attempted under the jurisdiction of an International Federation.

UK Anti-Doping's agreement with the Department for Culture, Media and Sport (DCMS) includes the following key commitment:

 Ensure at least 60% of Missions across the programme are no advance notice, out-of-competition tests

Table 3: Possible Anti-Doping Rule Violations – Summary of category of substance (closed cases, reported in the past 12 months)

The following table details the categories of substance for all closed cases reporting in the past 12 months. Possible anti-doping rule violations are grouped according to the categories outlined in the World Anti-Doping Code 2010 Prohibited List.

Of the 31 possible anti-doping rule violations listed, 8 (26%) were concluded as "no case to answer".
