## Conditions of Entry

I understand that power boating can be dangerous for the less experienced unless conducted in a controlled environment. I therefore agree to comply at all times with the instructions of the supervisor in the boat, particularly with regard to the handling of the boat, the wearing of my buoyancy aid, and the wearing of suitable clothing for the conditions.

I understand that the organisers may cancel the event at any time in the event of bad weather or if any of the equipment becomes unfit for use in such a way as to make the event dangerous for participants.

I accept responsibility for any injury, damage or loss to the extent caused by my own negligence.

I agree not to participate in the event whilst under the influence of alcohol, drugs or whilst otherwise unfit to participate.

I understand that the organisers may exclude anyone from the competition and evict anyone from the premises who refuses to comply with these conditions or who misconducts themselves in any way or who causes damage or annoyance to other persons.

I understand that the decision of the judges is final in all circumstances and that neither the RYA, nor Honda or Ribcraft have any jurisdiction to hear any appeal against the decision of the judges.
