Men's Windsurfing and Women's Windsurfing Interpretation of RRS 1.2 Life-Saving Equipment and Personal Flotation Devices. Fundamental rule 1.2 requires a boat, which includes a board, to carry adequate life-saving equipment on board, unless her class rules make some other provisions. There is no such provision in the RS:X class rules. Class rule C3.2 is a "closed class rule" as defined in ERS C2.2. As there is no provision in class rule C3.2(a) to carry any other safety equipment than a PFD, a PFD must be on board at all times. Fundamental rule 1.2 further refers to personal flotation device adequate for the conditions. At this event athletes are advised to wear this flotation device (SI 2.1) but it is not required unless flag Y is displayed.	3 AUG 2011
