Pre-Consultation on the draft UK Marine Policy Statement: A paper for discussion – UK 12th March – 7th May 2010

The MPS will be the first step in the new marine planning system to be introduced around the UK. It will provide the high level policy context within which Marine Plans will be developed, and set the direction for marine licensing and other authorisation systems. You are invited to contribute your views and comments on the draft MPS and supporting outline Impact Assessment.

The pre-consultation period closes on 7 May 2010. A formal consultation on the MPS and supporting policy documents will take place in summer 2010.

Statement of Public Participation

The Statement of Public Participation (SPP) has been updated to reflect the plan for continued engagement on the development of the Marine Policy Statement. The SPP highlights the ways in which anyone interested in our seas can get involved in the development of the Marine Policy Statement.

Public Consultation on Marine Licensing Enforcement – England only 9th March – 1st June 2010

The UK Government launched a public consultation on 9th March on its approach to enforcing the new marine licensing system to be established under the Marine and Coastal Access Act 2009. This is an important opportunity to influence the legislation at an early stage in its development and will help shape an effective enforcement system that is transparent, efficient and fair.
