| Young Adult: | Individual adults under 24 years of age, who are not students. | £ 86 |
| Student:² | Adults in full-time further education, and under 24 years of age | £ 59 |
| Junior: | Young person under 18 or up to and including academic year 13. | £ 28 |
| Associate: | Non-sailing social member only, normally a former full member (including partner). | £ 56 |

- New members joining prior to 1st March and paying in full can renew at 2011 rates (available on request)
- Note 1: 50% discount on published Membership Fees for persons on Income Support.
- Note 2: 50% discount on published Membership Fees for Students living away from home and more than 50 miles from the club

All ages in membership rules relate to age as at 1st March.

All sailing members will be expected to do at least one sailing duty (RO/rescue etc), and a Canteen duty.

| Group 3: | Medium dinghies, up to 1.8m beam or up to 4.6m long (eg Miracle) | £ 84 |
| Group 4: | Large dinghies, over 1.8m beam or over 4.6m long (eg Laser 4000, Contender) | £ 97 |
| Sailboard rack: | Storage fee per rack space stored in annexe (kayak or up to 3 boards) | £ 26 |
