URGENT NOTIFICATION TO ALL F2000 DRIVERS

Dear F2000 drivers.

We herewith quote extract of the Council Minutes regarding the F2000 Promoter.

"C.D. Strang reported on the Executive Committee decision which terminated the F2000 promotional contract with J. Del Palacio in December 2006.

All Council members had received a legal expertise by Avocat Dr. Kuhl and Maitrise en Droit Francaise Dr. Hartan (based on the Monegasque law). Legal consultant Kimon Papachristopoulos explained the situation including the possible legal risks for U.I.M. on the basis of this expertise.

The Council ratified the action by Executive Committee as follows : 10 in favour – 1 against – 3 abstentions"

A meeting has been scheduled end of this month to finalize the F2000 programme for 2007. The full F2000 calendar will be published by mid March and the Scandinavian Series already listed on the calendar are at present maintained at the given dates.

We will shortly release the procedure for the Superlicense application.
