Booking terms and Conditions 2013

- 1. Contract: Your contract is with Sail Ionian.A booking is made only when your deposit has cleared and a 'Confirmation' has been issued.Payment of a deposit implies acceptance of these Booking Terms and Conditions both for you and all members named on the 'Booking Form'.
- 2. Payment: A deposit of 25% of the Charter cost is required to confirm a booking. The balance must be paid at least 6 weeks before the commencement of the Charter. If your payment of the balance is not received by the due date, we reserve the right to cancel the booking with consequent forfeiture of the booking deposit. Bookings less than 8 weeks prior to the charter date must be paid for in full prior to a Confirmation Invoice being issued.
- 3. Yacht Arrival: Before joining the yacht, the charterer agrees to provide a completed booking form, which includes your sailing resume and passport details of charterer and crew. The yacht provided will be ready for charter in fully working order, with full tanks of fuel and water and ready to go sailing. The charterer should inspect the yacht and by agreeing in starting the charter, accepts the yacht is seaworthy and in charterable condition. In the event that a yacht is unavoidably unavailable for the holiday or training course, we reserve the right to replace it with a similar vessel or alternatively fully refund all charter fees paid to ourselves.

4. Conditions

(a) Bareboat Charter Sail Ionian offer the yacht for charter on the condition that the person identified on the 'Booking Form' as the charterer or his nominated skipper has adequate sailing experience to handle a yacht of the size and type chartered and can be ably assisted by at least one member of the crew. If, in the judgment of the Sail Ionian management, if the charterer is not competent to operate the yacht, Sail Ionian reserves the right to insist that the charterer takes a Sail Ionian skipper at the charterer's own expense. The charterer will also, prior to commencement of the charter, sign an agreement for bareboat charter which will incorporate the legal requirements for yacht charter in Greek waters. The charterer will also sign to say they will follow the operating and servicing instructions relating to engine, electrical and mechanical systems as advised in the yachts standard operating procedures. During the charter, the charterer will:

Inform Sail Ionian by telephone, as soon as possible, of any damage to the yacht, its engine or gear. Will

not accept outside assistance or a tow before agreeing a fee.

Will remain within the pre-determined cruising area.

Will return the yacht by 18.00 on the last day of charter and vacate by 09.00 on the day of departure

In the event of breakdown of equipment please inform Sail Ionian immediately who will agree and authorise any necessary repairs prior to them being carried out. For an authorised repair not carried out by Sail Ionian staff, prior agreement must be made with Sail Ionian management and a receipt must be obtained. The agreed amount will be refunded in the case of repairs, only when repairs are resulting from normal and natural wear.

(b) Skippered Charter The yacht on charter will be skippered by a designated Sail Ionian Skipper.

During the charter, the charterer will:

Inform Sail Ionian by telephone, as soon as possible, of any damage to the yacht, its engine or gear if the skipper is not present during the event.

Will not accept outside assistance before the skipper is present.

Will not operate the dinghy under the influence of alcohol, drugs or other substances and understands that if the skipper is not on board when the dinghy is being used, any damage to the dinghy will the charterer's own expense to be paid at the time.

(c) RYA Training Courses The yacht will be skippered by a qualified RYA Instructor. During the training, the clients will not accept

- any outside assistance before a skipper is present.
- 5. Skippers and Instructors: If you have a Sail Ionian skipper on board the yacht he will normally require a cabin and the charterer is responsible for his/her food.. Tipping is at the discretion of the client.
- 6. Assisted Skippering: We provide a skipper whilst you brush up on your skills, he/she will assist in familiarising you with the boat, mooring, reefing sails etc. The sailing area is a little restricted as the skipper needs to return to base and in some circumstances, if the destination is further afield, the skipper's travel will be at the expense of the charterer.
- 7. One Way Charges will apply for collection, and return if not from Vliho, Lefkas.
- Returning the yacht: The yacht will be returned to the Sail Ionian designated point of return by the agreed timings as per the holiday confirmation. On the morning of the last day, the charterers must vacate the yacht by 09.00am on the last day unless agreed otherwise as per confirmation.

If the charterer is late when returning the yacht, the charterer agrees to pay a late fee which is charged on an hourly rate of the pro rata charter fee. On the condition of a skippered charter where the vacht is delayed due to the lateness of the charterer, similar late fees will be charged.

9. Cancellation: If you have to cancel the charter for whatever reason, the lead name on the 'Booking Form' must advise us in writing. The cancellation will be effective from the date received and the following cancellation charges will apply: More than 8 weeks prior to charter commencement date: deposit only. 4 - 8 weeks prior to charter commencement date: 60% of charter cost. Within 4 weeks of charter commencement date: 100% of charter cost. Due to exceptional circumstances such as hurricane warning, if the charter must be cancelled by Sail Ionian, the charterer will receive a full refund of monies paid to Sail Ionian or the opportunity to put charter monies returned towards another Sail Ionian holiday at the next available date.

Sail Ionian will NOT be liable to any additional expenses that are indirectly or directly a result of the charter cancellation such as travel, alternative accommodation, alternative holiday arrangements etc.

- 10. Holiday and Travel Insurance: For your protection and peace of mind we insist that clients take out holiday insurance. This can be arranged through your own insurance broker or at most travel agents.
- 11. Yacht Insurance: Insurance is maintained on the yacht during the period of charter to provide a full indemnity against the loss of or damage to the yacht and an indemnity of over £1,000,000 for any damage to or injury to any third party. In addition, for charterers sailing bareboat, the Charterer will be liable to the extent of his security deposit for such loss, damage or injury for each and every accident. In this context third party does not include any person aboard the Charterer's yacht or in the Charterer's party. A fully refundable security deposit will be required and will be paid in cash or by credit card prior to the commencement of the charter, and refunded on successful completion of the charter, excepting if any damage occurs, in which case it will be retained until completion of all damage repairs, and any balance will be refunded, after deducting, repair costs and any direct or indirect costs, as a result of the boat being repaired, such as loss of
- 12. Security Deposit and Damage Waiver (Bareboat Charter Only) A Security deposit payment is paid in Greece by cash or card and is normally fully refundable, loss or damage to the yacht and its' ancillary equipment or the loss of non insurable loose items such as dinghy, lifesaving equipment, outboard engine, GPS, etc. will forfeit all or a portion of the security deposit. Not withstanding the above, the charterer, is responsible for the repair or replacement of any loss or damage caused by malicious or negligent use or whilst under the influence of alcohol or drugs. Late return of the yacht may also cause the security deposit to be forfeited. A non refundable

damage waiver may be paid as "an insurance" for the amount of the security deposit, this is paid as an alternative to the securitydeposit. Not withstanding the above the charterer, is responsible for the repair or replacement of any loss or damage caused by malicious or negligent use or whilst under the influence of alcohol or drugs.

- 13. Maintenance: If the vessel is out of commission due to a maintenance fault, Sail Ionian accepts that the charterer will be reembursed for loss of hours sailing time providing the charterer has informed Sail Ionian management in a timely fashion and has given the company necessary time to make the repairs. Sail Ionian will not be liable for any loss of sailing time, if the damage is due to operator error or carelessness. In the case of operator error or carelessness, such service call outs, may be chargeable to the client.
- 14. Additional Expenses: The charterer agrees to accept the yacht agreement as above and agrees to pay all running expenses for the yacht during the time of charter. This will include, but may not be limited to, fuel, water, food and other consumables, port and mooring charges, customs fees and dockage. The charterer will return the yacht with full water and fuel in the dinghy and yacht.

 Transfers are not included in the charter fee but can be arranged at extra cost.

Cleaning is included in the charter but the yacht must be returned in a clean and tidy condition. For yachts not returned in this condition we reserve the right to deduct reasonable cleaning costs from your security deposit.

15. Charterers Authority: Full authority regarding the operation and management of the yacht is hereby transferred to the charterer for the duration of the charterer contract. The charterer must ensure they are always present on the yacht when the yacht is underway and is fully responsible to ensure the dinghy and ALL other items are securely stowed and that all normal engine checks have been completed prior to the yacht departing each day. In the event of a skippered charter or where a Sail Ionian skipper is present on board, authority is transferred the skipper although the skipper is not responsible for actions taken by the charterer and their guests.
