**The Jubilee Sailing Trust (JST) is a small organisation with a huge heart and an important task to achieve.**

Our two tall ships, Lord Nelson and Tenacious, are the only two of their kind in the world that have been designed and built specifically with the aim of promoting complete integration between men and women, young and old, able bodied and physically disabled.

## Ways to leave a gift in your Will

**There are three main types of legacy to consider. Find out about all three here, and read the suggested wording for leaving us a legacy:**

### **Residuary legacy**

Part, or all, of your estate (after debts, funeral costs and pecuniary gifts are paid).

### **Pecuniary legacy**

A specific sum, which can be index-linked to safeguard its future value.

### **Specific legacy**

A particular item to be used or sold by the beneficiary.

### **If you have made a Will**

It is possible to make a change to your Will at any time. If you have already made a Will or would like to make amendments to an existing Will and would like to include the JST, we would strongly suggest that you consult a solicitor.

### **If you haven't made a Will**

Making a Will is best done with the guidance of a solicitor and can be inexpensive. Having a Will is the only way that you can make provision for family, friends and causes that are dear to you while ensuring that your wishes will be carried out.
