We have successfully negotiated free Adventure Activity Licences until October 2010 for OnBoard clubs, following lengthy discussions with the Health and Safety Executive (HSE).

We were granted an umbrella licence for OnBoard clubs last year, which was subsequently withdrawn when the HSE insisted that every club must, where needed, hold its own licence. However, with the

backing of Sport England, we have now managed to satisfy them that RYA recognition fulfils all necessary safety criteria.

Cost would have been a major issue if clubs had to pay for a

licence, with no improvement in safety in return for the increased bureaucracy and expense. We were concerned that Sport England grants intended for equipment and training, would have been swallowed up by licence fees. In the worst cases, the fees would have excluded many clubs from getting involved at all.

There are currently over 155 RYA OnBoard clubs and centres across the UK, providing some 60,000 windsurfing and sailing sessions to kids each year. We hope the arrangement with the HSE will enable these numbers to keep growing.

Discussions with the HSE are ongoing with regard to the situation beyond 2010.

# Vetting and Barring Scheme update

In October this year there was due to be a new scheme for registering staff with the Independent Safeguarding Authority (ISA). This has been postponed until November 2010, and the current Disclosure process will remain in place for the 2010 summer season.

So, from November 2010, the new ISA registration scheme will apply to people working or volunteering 'frequently' or 'intensively' with young people or vulnerable adults. Organisations will be legally obliged to check that their staff and volunteers in relevant roles have registered.

A parallel scheme called the Protecting Vulnerable Groups (PVG) scheme will operate in Scotland.



Unlike the current Disclosure process (CRB, Disclosure Scotland or Access NI), this will be a one-off registration and will not have to be repeated for each new employer. It will still be free for volunteers, but for centres employing paid staff, registration with the ISA will cost £28 per person, plus the existing Disclosure fee (£36 in England

and Wales, £30 in Scotland, £20 in Northern Ireland).

There will be a five year phasing in period, so someone who has already obtained a Disclosure and stays in the same role will not be required by law to register until five years after the issue of their certificate (by 2015 at the latest). However they will need to

register if they are joining the workforce for the first time or moving to a new role.

Disclosures will continue to be available in addition to registration, so employers wanting to check the applicant's full criminal record may do so. Registration with the ISA simply ascertains whether or not they have been barred from working with vulnerable groups.

We will attend consultations on the operation of the new schemes and monitor guidance as it is published. Based on that, we will provide training centres and clubs with clear information on the roles and positions covered by the legislation well in advance of implementation.

Sport should always be fun and safe. It's not your responsibility to investigate what's happened, but it is your responsibility to report concerns.

The Child Protection in Sport Unit has brought out a set

of short online films giving examples of poor and good practice in clubs, and advice on what action to take. They feature a range of mainly ball-sport activities, although images of sailing feature at several points.

The film includes fifteen scenarios showing best practice examples of responding to and reporting concerns over the safety and well being of children in sport. They cover physical and sexual abuse, bullying, disability and racial discrimination of children.

# ATIS and RAINWAT...eh?

There has been, and still is, a fair amount of confusion around ATIS and RAINWAT. For those of you training customers to venture onto the inland waters of Europe, here are a few facts to help ease the confusion.

ATIS: Automatic Transmitter Identification System. Not to be confused with AIS (Automatic Identification System).

If you have an ATIS VHF set, every time you release the PTT switch, it transmits an audible signal containing the ATIS number that has been programmed into it. Your details are stored on a database maintained by the Belgian authorities, who can tell if you are misusing your set, transmitting on the wrong frequencies, or causing interference in the RAINWAT area. Expect a visit from the RAINWAT authorities if you get it wrong!

RAINWAT: Regional Arrangement concerning the Radiotelephone Service on Inland Waterways (in Europe). It is an arrangement between participating countries wanting to implement common safety principles and rules on



inland waterways. They decided that the harmonisation of radiotelephone services would contribute to this, particularly on busy commercial routes.

Initially, visiting ships and recreational craft from non-RAINWAT countries were exempt from the regulations. In January 2009, that exemption was removed.

#### What to do now

It is important to check the rules and laws for each country before using their inland waterways. Each country determines where its inland waterways start and finish, and whether it is mandatory to fit a VHF radio.

If you have to carry and use a VHF radio in a RAINWAT country, it must be capable of operating on the ATIS system and you should apply to OFCOM for a Notice of Variation to your licence. Click here to see the procedure for doing this.

Every vessel in the RAINWAT area must have on board the ship radio licence, the operator licence and a copy of the Arrangement. The Arrangement is not an easy read but is does contain important information on what

you can and cannot do. You can download a copy here.

## A few remaining grey areas

There is still some uncertainty about the definition of inland waters, which countries mandate the carriage of VHF in the RAINWAT area, where handheld sets can be used and whether non-ATIS VHFs can be used for a listening watch only.

We are keeping an eye on this and will post more information on the website as it becomes available. In the meantime you can read more here.

# ICCs – who can test for what?

Some RYA training centres can run practical tests for the International Certificate of Competence (ICC). The ICC is split into various categories, and your centre's recognition determines which categories you can test for. Here is a quick rundown.

ICC category	Which recognised centres can test for it?
Sail up to 24m (certificates will also be endorsed 'Power up to 10m' to allow use of a tender)	Sail cruising centres
Power up to 10m (on centre's boat up to 10m)	Powerboat, motor cruising and inland waterways centres
Power up to 10m (on customer's boat up to 10m)	Powerboat, motor cruising and inland waterways centres
Power up to 24m (on centre's boat 10m to 24m)	Motor cruising and inland waterways centres
Power up to 24m (on customer's boat over 10m)	Powerboat, motor cruising and inland waterways centres

If your centre is one of those listed in the table, you will automatically be granted permission to test for the relevant types of ICC.

Applications for ICCs are checked to ensure the test centre holds the correct type of recognition for the ICC applied for. If it doesn't we are likely to decline the application. To avoid disappointing your customers, please only run the tests you are allowed to do.

Note: We can only issue ICCs to British citizens or bona fide British residents (proof required). We have to turn down applicants who fulfil neither criteria. Don't let down your customers or embarrass your centre by signing applications for ineligible people. If you have any queries please **email us**.

# RIBs and vertebrae



Research by the Royal Marines has shown that crew seated in a powerboat can experience forces as high as 14g. That can be pretty damaging to a super-fit Marine, never mind the public.

Like any form of boating, powerboating carries inherent risks. If you know and understand those risks, they can be kept under control.

Avoiding injury is a combination of good driving and posture. In many high speed craft there are no seats, so the driver and crew stand to take the strain through their legs, while braced against a padded backrest. Experienced RIB drivers approaching a heavy landing often stand to take the weight off their back. This is fine, but you must keep your knees bent.

If the crew is sitting down, the seats need to encourage good

posture and have handholds and, for severe weather, foot straps as well. Sitting on sponsons is fine in sheltered water but you should have a secure handhold inboard – the ropes around the sponsons won't do.

As instructors, you need to teach your students to watch the sea closely and choose their course through waves carefully. Continually adjusting the throttle can help to power through the waves but avoid taking off the other side. Teach them to alter the power trim to prevent the bow lifting too high in a head sea or nose diving in a following one.

It's a skilful business, but there is plenty of information on the Advanced course and in our various handbooks.

Over the next year we will be looking at how to emphasise the importance of minimising the possibility of back injury through our courses and publications.

### Get the numbers right!

A little reminder about teaching ratios on the Personal Watercraft course.

One instructor can teach up to six students on three machines. There should be no

more than two students per machine.

Please make sure that your operating procedures reflect this, and that you stick to it on the water.

# New trapeze harness safety standard

Over the last four years our Technical department has been working hard on safety standards for quick release harnesses, in an effort to avoid a repeat of recent entrapment cases. The new standard was published in June.

Drawing on expert knowledge and existing standards for similar equipment, the standard was developed to trouble shoot

issues like the need for full rotation release of trapeze hooks and simple problems such as sand getting into the mechanism when launching from a beach.

Any quick release system on the market must now comply with the standard and, as trapeze harnesses are categorised as Personal Protective Equipment, those complying with the



standard will now sport a CE mark.

Ken Kershaw, RYA Technical Manager commented: "The RYA has led this project and we have been working tirelessly on it for

over four years. The publishing of this standard worldwide is testament to the credibility of the RYA's work internationally and a massive success for us and all sailors who use trapeze harnesses."

Navgational warnings (WZ) for NAVAREA1 and the UK Coast can now be obtained from the UKHO website as well as by NAVTEX and broadcast on VHF/ DSC Radio.

Many of these warnings are of a temporary nature, but others may remain in force for several weeks and may be superseded by Notices to Mariners. This should be especially useful for shoreside pre-planning of passages and for training centres to provide the most up to date information to their instructors and clients.

More details about the Nav warnings and recent changes to Maritime Safety Information are available on the RYA website, or through the **UKHO**.



You don't need to be a championship winning sailor to become a Racing Coach. All we are looking for are good club racers with personal knowledge

of club and/or regional racing and a broad base of coaching skills. You will need enthusiasm for the sport and a willingness to pass on your knowledge and skills.

The course takes two days (normally a weekend) and is a mix of theory and practical sessions afloat. The tutor will cover some basic theoretical aspects of coaching but the majority of the course takes place afloat, giving you the opportunity to run short sessions followed by a debrief and discussion with the tutor and your fellow sailors.

To become a fully fledged Racing Coach you will also need a RYA Powerboat Level 2 certificate and a one day first aid course (the RYA's first aid course is ideal). You can find your local training centre for both these courses through the search on our website.

There are a number of variations to the standard Racing Coach Level 2 course, aimed at specific coaching issues. These courses cover windsurfing, team racing, match racing and a four day keelboat course. Details can be found here.

Experienced Racing Coaches can further improve their coaching skills by attending the Racing Coach Level 3

course. We only run one of these courses each year, spread over two weekends at Bisham Abbey. There is some work to be completed on the job between the weekends.

# Category C first aid kits

Are you MSN 1768 and MSN 280 compliant?

If you use Coded boats up to Category 2 for teaching or charter purposes you must have a Category C first aid kit to comply with MSN 1768 and MSN 280.

Choosing a first aid kit in a



sealed bag which clearly shows the expiry day on the front will meet this standard.

For those of you who make up your own first aid kits please check the details in Appendix 6 of the Recognition Guidance

Remember too, keep all medicines in a box with the instruction notes and mark any foreign bought items with details in English.



It is essential that all items are in date. Check both the medicines and the bandages. Drugs that have expired should be disposed of, as they can be ineffective or harmful.
