## **Photograph Permission Form Use of Personal Information**

Occasionally, we may take photographs of the children taking part in activities at our club. We may use these images, for example, in our club's brochure or other promotional material, as well as on our website or on project display boards.

From time to time, our club may be visited by the media who will take photographs or film footage of a visiting dignitary or other high profile event. Children will often appear in these images, which may then appear in local or national newspapers, or on televised news programmes.

This form gives the club the right to use the whole or part of your child's contribution in all media. We very much hope to use your child's contribution, but we cannot guarantee to do so.

1. You assign to the club the copyright and all other rights in your child's contribution for use in all media now known or which may be developed in future
2. You confirm that where reputable, bona fide sailing magazines require full names in sailing reports and to accompany pictures of prizewinners we may give this information
3. You confirm that you consent to images of your child being used in conjunction with publicity by the club, the Royal Yachting Association and / or title sponsor of RYA OnBoard.

### **Conditions of Use**

- We will not use any photographs or recordings for a new purpose after you and your child have left UTSC.
- We will not use personal details or full names (which means first name and surname) of any child in a photographic image on video, on our website, in our organisation brochure or in any of our other promotional material without good reason. For the avoidance of doubt "good reason" includes using the full name of a child in a newsletter to club members if the child has won an award.
- We will not include personal e-mail, postal addresses, telephone or fax numbers on video, our website, or in other printed publications which are used externally.
- If we use photographs of individual children, we will not use the full name of that child in the accompanying text or photo caption, (except as in 2 above).
- If we name a child on the text, we will not use a photograph of that child to accompany the article, (except as in 2 above).
- We may use group photographs or footage with very general labels, such as UTSC cadets.
