

#### Dogger Bank Teesside A & B

Forewind is a consortium comprising four leading international energy companies which joined forces to successfully bid for the right to develop the Dogger Bank Offshore Wind Farm Zone as part of The Crown Estate's third round of UK offshore wind farm leasing (Round 3). The Dogger Bank Zone is in the North Sea, located between 125 and 290 kilometres (77 and 180 miles) off the UK coast. Due to its size it will be developed in stages, with Dogger Bank Teesside A & B the second stage of development within the zone.

Dogger Bank Teesside A & B is a proposed offshore wind development comprising two offshore wind farms, each with a maximum generating capacity of up to 1.2 gigawatts (GW). In total it has the potential to generate around 8 terawatt hours (TWh) of green power every year, which is equivalent to the electricity used annually by approximately 1.8 million British homes.

The development will connect via underground cables into the national grid at the existing Lackenby substation near Eston, in Redcar and Cleveland.

### Final pre-application consultation 4 November to 20 December 2013

This is an advance notice of the start of the final pre-application consultation. Presenting the detailed proposals for Dogger Bank Teesside A & B, the consultation will be held between **4 November and 20 December 2013**.

Consultation responses must reach Forewind by **Friday 20 December 2013** to ensure that they are considered.

Forewind anticipates that the application will be submitted to the Planning Inspectorate early in 2014. Therefore this consultation will be the last formal opportunity for you to submit comments before the application is submitted.

Pre-application consultation provides the main opportunity for the local community to engage with Forewind and help shape the proposals. We therefore encourage interested parties to provide comments or information about any part of the Dogger Bank Teesside A & B proposal during this consultation process.

# Publication of Dogger Bank Teesside A & B Statement of Community Consultation

This also serves as notice that Forewind has published a Statement of Community Consultation (SoCC) for Dogger Bank Teesside A & B, in accordance with Section 47 (6)(b) of the Planning Act 2008.

The SoCC describes how Forewind proposes to consult the local community about the proposals for Dogger Bank Teesside A & B.

This SoCC is an update to the one Forewind published in May 2012 for Dogger Bank Teesside. As Dogger Bank Teesside has now been split into two separate development consent order applications ("Dogger Bank Teesside A & B" and "Dogger Bank Teesside C & D") Forewind has produced a SoCC explicitly for the Dogger Bank Teesside A & B application. A separate SoCC will be published for Dogger Bank Teesside C & D at a later date.
