INTELLECTUAL PROPERTY AT WCL

American University Washington College of Law (WCL) offers an unparalleled opportunity to pursue the advanced study of intellectual property law. The law school offers a full range of intellectual property and information law courses, one of the nation's first intellectual property legal clinics, numerous events and projects organized by its path-breaking Program on Information Justice and Intellectual Property, and a location in Washington D.C.— the center of U.S. and international intellectual property law and policy making.

Intellectual Property Curriculum

Although J.D. students do not formally concentrate in a field of study, the curriculum at WCL is designed to enable J.D. students to develop a broad and deep expertise in IP and information law subjects. In addition to an extensive and expanding course list (see below), WCL is one of the only law schools in the nation to permit first year law school students to take Introduction to Intellectual Property, thus enabling concentrated study in advanced IP topics during the latter two years of the program.

Glushko-Samuelson Intellectual Property Law Clinic

WCL houses one of the first intellectual property law clinics in the nation, the Glushko–Samuelson Intellectual Property Law Clinic. Students in the year-long clinic represent a wide range of IP clients who would not otherwise be able to afford high–quality representation, including creative artists, non–profit organizations, small inventors and entrepreneurs, scholars, and traditional communities. Students provide clients legal advice and represent them in a variety of forums, including U.S. and international agencies (e.g. Copyright Office, Patent and Trademark Office, World Intellectual Property Organization), as amicus curiae in federal appellate courts, including the U.S. Supreme Court, and in legislative advocacy before the U.S. Congress.

Program on Information Justice and Intellectual Property (PIJIP)

WCL's IP program is unique in its efforts to infuse IP and information law analysis and practice with a commitment to promoting social justice. This commitment arises from a recognition that IP protections do more than create incentives to create and innovate, they structure the distribution of essential cultural and scientific resources in ways that can have direct and unjust social, class and global impacts. Through research, scholarship, public events, advocacy, and provision of legal and consulting services, the Program on Information Justice and Intellectual Property (PIJIP) promotes approaches to domestic and international IP and information laws that further the achievement of human rights and social justice. WCL students participate in PIJIP activities in numerous ways, including as research assistants, event planners and project coordinators.

Externship Opportunities

Among the many advantages of studying law in Washington, D.C., is the opportunity to integrate practical experience with the theory of the classroom. WCL's Supervised Externship Program provides academic credit for unpaid legal work for at least 140 hours over the course of a semester. WCL externs have worked in a wide variety of IP-focused organizations, including with the U.S. Copyright Office, the U.S. Patent and Trademark Office, legislative committees of Congress, and non-profit organizations and associations that advocate for the interests of IP owners or the consumers of IP-protected products.

Career opportunities

WCL alumni occupy high level positions in leading IP law firms, non-governmental organizations and in government offices throughout the nation. Given WCL's location, alumni have a particularly strong presence in Washington D.C., where some of the nation's largest and most prestigious IP institutions are based.
