## CIRCUIT POWERBOAT LICENCE APPLICATION

#### HOW TO APPLY AND THE REQUIREMENTS FOR ISSUE

All UK residents who wish to take part in Powerboat Racing in the United Kingdom or the Northern Ireland must hold a valid Powerboat Racing Licence issued by the Royal Yachting Association.

All UK residents who wish to take part in International racing must hold a valid International Powerboat Racing Licence issued by the Royal Yachting Association.

## 1. PROVISIONAL LICENCE

This Licence is issued to all newcomers and those returning to the sport after a break of more than two years. Competitors are required to undertake a Powerboat Race Training program, full details of this can be found in RYA Powerboat Race training manual, PB3 & the PB2. On satisfactory completion of this training and written proof of competency, the RYA will issue a Provisional Powerboat Racing Licence.

## 2. NATIONAL LICENCE

Competitors wishing to upgrade to a National Licence must compete in five Powerboat Racing Test & Club events and demonstrate competence and ability to the satisfaction of the OOD. Competitors MUST present their Powerboat Racing upgrade form to the OOD prior to the drivers briefing. This will be signed by the Officer of the Day at the end of the event providing they are satisfied with the competitor's performance in accordance with the PB2 Rules.

Foreign competitors who are resident within the UK and wish to take a UK national Licence must provide written permission from their own National Authority and proof of previous racing experience by the submission of a Powerboat Racing CV.

## 3. INTERNATIONAL LICENCE

Competitors wishing to upgrade to an International Licence MUST compete in three National events and demonstrate competence and ability to the satisfaction of the OOD. Competitors MUST present their Powerboat Racing upgrade form to the OOD prior to the drivers briefing.

This will be signed by the Officer of the Day at the end of the event providing they are satisfied with the competitor's performance.

Foreign competitors who are resident within the UK and wish to take a UK national licence must provide written permission from their own National Authority and proof of previous racing experience by the submission of a Powerboat Racing CV.

All competitors applying for an international Powerboat Racing Licence must comply with all UIM Anti-doping requirements and complete the UIM declaration form included.

#### 4. UIM SUPER LICENCE

Competitors who race in F1 and F2 must in addition to their UK International Licence hold a UIM Super Licence.

UIM Super Licence application forms and procedures can be downloaded from either the RYA website — www.rya.org.uk (go to Circuit Forms for competitors) or the UIM web site www.uimpowerboating.com

All applicants are reminded that an additional UIM medical examination is required and that the deadline for a Super Licence is a minimum of four weeks before your first event.

#### 5. TRAINING & EVENT LICENCE

Event licences are issued on separate forms in accordance with the PB2.

#### 6. POWERBOAT RACING LICENCES FOR COMPETITORS UNDER 18.

- All competitors under the age of 18 are required to submit an RYA Certificate of Competence Form for the relevant race category, signed and completed with their Licence Application Form.
- b) RYA Officials who countersign a Certificate of Competence form are reminded that it is their responsibility to ensure that the named competitor has undergone a Powerboat Race Training program, and in their opinion, is competent to participate in Powerboat Racing for the classes identified.

### 7. IMMERSION TESTS & MICRODIVE

If you are racing in a class that requires an Immersion Test & Microdive qualification i.e. restraint / canopied boats, then you must have undertaken your test before applying for your Licence. **See RYA** website for details of venues and dates when tests are being offered.

#### 8. WHAT DOES THE POWERBOAT RACING LICENCE PROVIDE FOR YOU?

All RYA Provisional, National and International Licence holders will receive free RYA membership. (Your Membership card and pack will be sent separately to Licence)

All competitors are provided with Third Party Public Liability insurance cover listed below and detailed in the policy documents:

- 1. Third Party risks on land to the maximum limit of £10m
- 2. Third Party risks on water whist racing or during official practice and training to a maximum limit of £10m
- 3. This cover only applies once a competitor has "signed on" at Race Administration at the beginning of the event. All such covers ceases once the competitor has "signed off"

#### **Excess amounts do apply**

#### THIRD PARTY LIABILITY INSURANCE IN UNITED KINGDOM

Payment of the Licence fee ensures that the holder is covered by the Powerboat Racing third party liability insurance policy arranged by RYA through Arthur J Gallagher, subject to the terms and conditions of the insurance policy. This insurance policy applies to Powerboat Races (including official practices) organised by RYA-affiliated clubs and approved by the RYA.

A copy of the insurance policy terms and conditions is available from the RYA Powerboat Racing Department.

**OVERSEAS THIRD PARTY LIABILITY INSURANCE** - This is automatically included with an international status Licence.

This means that holders of International Licence participating in worldwide events, (excluding the United States of America and Canada), will automatically receive a cover note (insurance letter, or Licence endorsement), to extend the conditions of the insurance applying to the UK — this insurance only comes in force if the race organiser's own insurance fails — the RYA cover is not the PRIMARY LAYER. Competitors MUST purchase the organiser's own insurance at UIM recognised foreign events.

A copy of the insurance policy terms and conditions is available from the RYA Powerboat Racing Department.

## 9. WHAT DOES THE POWERBOAT RACING LICENCE NOT PROVIDE FOR YOU?

- a) Competitor to Competitor liability
- b) Personal Accident and Death benefit.
- c) Legal Expenses cover.
- d) Loss of Earnings insurance.
- e) Travel and Medical Insurance (when travelling to foreign events)
- f) All Year Round Third Party Public Liability (for activities outside of RYA organised Powerboat Racing events) or Comprehensive cover on your boat/ski.
- g) Fire, Theft insurance cover on your own craft/trailer check to see if your car policy covers trailing.
- h) Check all your insurance policies to ascertain whether you are covered whilst Powerboat Racing. It is imperative that you declare this.
- i) ALWAYS SEEK INDEPENDENT PROFESSIONAL ADVICE IN INSURANCE MATTERS

#### PART 2A - MEDICAL NOTES FOR THE EXAMINING DOCTOR:

Competitors in powerboat races held under the jurisdiction of the RYA and the RYA affiliated clubs are required to pass the RYA approved medical examination.

No competition licence will be issued until the Medical Examination Form is completed and signed by a Registered Medical Practitioner.

Competitors are required to declare any physical or mental disability.

Competitors must sign the declaration which permits the RYA to request details of their medical history from their General Practitioner or from any hospital or other practitioner.

For this reason the examining Doctor is asked to ensure that his full address in entered upon the form.

The fees for the Medical Examination and any Specialist Examinations are the responsibility of the applicant (competitor) and not the RYA, and would normally be expected to follow the guidelines currently recommended by the BMA.

The medical examination should be carried out to a standard similar to that required for Life insurance. Diabetics may apply to the RYA Medical Officer for the issue of a licence to be considered. Epileptic applicants will not be issued for a licence to race.

Applicants who have had, or still suffer from the following may be regarded as unfit to hold a powerboat licence:

- (i) Myocardial infarction.
- (ii) Myocardial ischaemia.
- (iii) Coronary artery by-pass surgery.
- (iv) Serious valvular disease of the heart or other cardio vascular conditions which give rise to cardiopulmonary Problems.
- (v) Severe hypertension which has given rise to cardiopulmonary problems.
- (vi) Misuse/abuse of alcohol or illicit drugs in the last 3 years.

Amputations of any type could be incompatible with fitness to race apart from minor amputations of one or two fingers where the normal function of the hand is unimpaired. Absence of a thumb could also be incompatible with fitness. Where the functioning of the limbs is limited free movement should not be less than 50% or normal capability.

Patients requiring the use of any orthopaedic appliance should declare this so that specific consideration can be made of the case by the RYA Medical Officer.

#### Eyesight:

Normal binocular vision is required with full visual fields, normal eye movements and normal stereoscopic vision. Normal colour vision is required. (Note: if colour deficiency – this can be referred to RYA Medical Officer for second opinion)

The vision in each eye to be at least 6/9 either before or after correction

If glasses or contact lenses are worn this should be stated on the form

Contact lenses may be worn provided there is reasonable vision in both eyes without the lenses in place.

The visual acuity in each eye to be stated both with and without the contact lenses in place.

The examiner should bear in mind that powerboat racing may take place at high speeds over turbulent water in confined areas, or upon waters used by the public, when considering the suitability of the application (competitor).

Note: Recognised Medical Certificates are acceptable providing the medical examination conforms to the RYA criteria (subject to approval of Medical Panel). These certificates are only valid in the year in which they were originally issued; therefore an annual medical examination is still required for subsequent years.

#### PART 3 APPLICATION FOR POWERBOAT RACING LICENCE: - to be signed at bottom of form

- a) I will not take any action which brings the UIM, the RYA or the sport into disrepute.
- b) I agree to be bound by the rules of the UIM and the RYA, and will not compete in any unauthorised event. I confirm that my application meets these requirements.
- I do not hold, and will not apply for a licence from another national authority whilst my RYA licence remains valid.

- e) I have read and understood the General Racing rules in the Circuit Racing handbook PB2 and the class specific rules to which my licence refers.

  - I am aware that non-compliance of any of the above rules and regulations could result in RYA disciplinary action. To the best of my knowledge the information given on this form is correct and complete.

#### f) Identification of Risk

I am fully aware and conscious of the actual and potential risks involved in active water sports, including drowning, hypothermia, physical injuries or death.

I accept that, by engaging in active water sports, my physical safety could be endangered. I am also aware that other competitors' actions, or inactions of the organisers of water sports events, including the drivers of safety craft, can also endanger my physical safety.

## g) Acknowledge of Risk

I acknowledge that it is up to me personally to assess whether any event or activity on the water is too difficult for me or my crew. I acknowledge that the safety of my boat and her entire management including insurance is my sole responsibility, and I am satisfied that the boat and crew are adequate to face the conditions that may arise in the course of the race.

I acknowledge that scrutineering does not constitute a condition survey of the craft and it is solely my responsibility to decide whether or not to start or to continue in any powerboat race. I acknowledge that the efficiency of the helmets and racing vests worn is solely my responsibility.

h) I have read, understood and agree to abide by the rules set out in PB2 (National Circuit Racing rule book). I also confirm that I have read & understood the enclosed Powerboat Racing Charter and Risk Statement.

NOTE: THE RYA RESERVES THE RIGHT TO REFUSE THE ISSUE OF & REVOKE AT ANYTIME, A POWERBOAT RACING LICENCE AT ITS DISCRETION.

# **IMPORTANT NOTES**

**DRUG AND ALCOHOL ABUSE** — the Powerboat Racing Division has a ZERO tolerance policy on this. Failure to comply with this policy would be classified as "bringing the sport into disrepute". The medical section of the Licence Application Form has a question relating to any abuse in the past three years.

## **ANTI-DOPING — TUE FORMS**

If you are taking drugs for medical reasons which contravene the list of prohibitive substances, you will need to fill out a TUE (Therapeutic Use Exemption) form enclosed and return it with you completed Licence application form — you only need to complete this form if you are racing internationally.

**DECLARATION OF MEDICAL FITNESS TO RACE** — All licensed competitors are required to have a medical examination on an annual basis before the issue of their new documentation. At each race competitors are asked to sign a "declaration of fitness to race" whether they are fully licensed or not, we believe that on some occasions there have been a few whose level of fitness has declined during the season, either through accident, injury or illness. It is imperative to make sure that you are fully fit before participating. PLEASE THINK CAREFULLY BEFORE PARTICIPATION.

## IN THE EVENT OF INJURY:

You will be required to declare whether you have suffered any injuries or trauma during a Powerboat Racing Event, and are sent to hospital for examination or treatment, then your Licence will be withdrawn by the organisers (a PB19 form is filled out and your Licence returned to the RYA). You will be sent a copy of the PB19 form and you must get a doctor's signature declaring you fit before you can race again, and your Licence will be reissued.
