# NOTICE OF RACE and RACE ENTRY FORM for

## Brading Haven Yacht Club and East Wight Combined Clubs 2016

## **PROGRAMME / SCHEDULE OF RACES**

Racing will take place on the dates and at the times published in the BHYC Programme and in the Schedule of Regattas published by the East Wight Combined Clubs (EWCC).

#### **SAILING INSTRUCTIONS**

All races will be held under the International Sailing Federation (ISAF) Racing Rules of Sailing (RRS), prescriptions of the RYA, SCRA Regulations and relevant Class Rules except as any of these are changed by the Sailing Instructions published by BHYC or EWCC.

#### **CONDITIONS OF ENTRY**

The race organisers shall not be liable for any loss, damage, death or personal injury howsoever caused to the owner/competitor, the skipper or crew, as a result of their taking part in the race or races sailed in the BHYC or EWCC programmes. Moreover, every owner/competitor warrants the suitability of his boat for the race or races. Buoyancy shall be in accordance with Class Rules (or as built, in the absence of any specific Class Rule).

Further, a boat is entirely responsible for her own safety, whether afloat or ashore and nothing, whether in the Notice of Race or Sailing Instructions or anywhere else, reduces this responsibility. It is for the boat to decide whether she is fit to sail in the conditions in which she will find herself. By launching or going to sea, the boat confirms that she is fit for those conditions and that her crew is competent to sail and compete in them. **The boat is required to hold adequate insurance and, in particular, to hold insurance against third-party claims of at least £3 million.** Nothing done by the organisers can reduce the responsibility of the boat nor will it make the organisers responsible for any loss, damage, death or personal injury however it may have occurred as a result of the boat taking part in the racing. The organisers encompass everyone helping run the race and the even and include the Organising Authority, the Race Committee, the Race Officer, patrol boats and Beach masters. The provision of patrol boats does not relieve the boat of its responsibilities.

Where the matter is not one to be determined under the Rules, competitors agree not to resort to any Court of Law or any tribunal until all internal remedies provided by ISAF or by the Court of Arbitration for Sport have been exhausted.

# RYA RACING CHARTER

Clubs of the EWCC implement the RYA Racing Charter and competitors will be required to undertake to sail in compliance with the Charter, which can be found at the front of the RYA Rule Book (Racing Rules of Sailing 2013-2016) or at the RYA website.
