# Privacy Notice – World Sailing Olympic Equipment Re-Evaluation Participants

This privacy notice tells you about the information we collect and process from participants in the sea-trials which form part of the 2024 Olympic equipment reevaluation process.

In collecting this information, we are acting as a data controller and, by law, we are required to provide you with information about us, about why and how we use your data, and about the rights you have over your data.

#### Who are we?

## What personal data do we collect?

When you participate in the sea-trials which form part of the 2024 Olympic equipment re-evaluation process we collect:

- Name
- Gender
- Date of Birth
- Email
- Nationalities held
- An endorsement from your MNA
- Address
- Contact telephone number
- Occupation
- Sailing club
- Your opinion on the equipment being evaluated as part of the re-evaluation process
- Accreditation Photo
- Details of your third party liability insurance
- Emergency contact information
- Details of any medical insurance policy
- Weight
- Height
- Your medical and surgical history \*
- Medication you take \*
- Allergen information \*

## Why do we collect this information?

We collect this information in order to process your application for, and on-going participation in, the sea-trials and to ensure you comply with the eligibility and other rules concerning these trials.

For the information marked with a \*, we collect this information to ensure that in the event of a medical emergency affecting you, we can provide the emergency services with necessary information to treat you.

#### What do we do with your information?

Your information is stored in our database which is only accessible by our staff. We may share limited parts of the information with panel overseeing the sea-trials and equipment re-evaluation generally, and some information may be included in reports provided to the World Sailing Council and other public reports but only if it is necessary to do so.

In the event of a medical emergency, we will share the information with the emergency services to allow them to treat you.

We will not use the information to make any automated decisions that might affect you.

The above uses of information may involve the transfer of your personal data outside of the European Union. Where this occurs, the data will be transferred in a secure and encrypted state.

# How long do we keep your information for?

We keep your information for as long as the equipment re-evaluation process is ongoing. We will review the information on a periodic basis and delete the information for participants who appear to have ceased participating in the sea-trials. If you wish us to delete the information, please contact us.

#### Your rights over your information

By law, you can ask us what information we hold about you, and you can ask us to correct it if it is inaccurate. You can also ask for it to be erased and you can ask for us to give you a copy of the information.

If we are processing your information based on your consent for us to do so, you can ask us to stop using your information by withdrawing your consent. You can do this by emailing, writing or telephoning us using the contact details above.
