

Malaria Unit Agreement

This agreement is between Concern Universal (CU) and The Against Malaria Foundation (AMF).

1. The purpose of the Malaria Unit is to reduce malaria prevalence in Malawi. What the Unit will do and how it will function are set out in the Terms of Reference below.
2. CU will run the unit, which will operate under CU procedures and policies. AMF will provide funding towards it on the basis set out in the attached budget. AMF has provided \$100,000 of this funding by the date of this agreement. The further amounts due from AMF are \$99,964 by 01Jul16, \$211,744 by 01Dec16 and \$224,349 by 01Dec17.
3. The initial term for this unit is three years starting 01 April 2016. It is understood this term is likely to be extended provided that the work done by the unit is successful. A review will be carried out during the first half of 2018 to agree on any extension.
4. CU may terminate this agreement if AMF fails to provide funding as agreed. In the event of 'force majeure' where an unforeseen event makes it impossible for CU to continue to provide the services of the unit, CU will return any amounts received from AMF which are unspent prior to termination.
5. AMF may terminate this agreement if CU substantially fails to carry out the terms of reference below. CU will return any amounts unspent, but will otherwise incur no liability to AMF.

Terms of Reference AMF Malaria Unit Malawi

The Terms of Reference for the Malaria Unit are as follows.

The Malaria Unit is part of Concern Universal, and follows the procedures, policies and reporting structures of Concern Universal.

The purpose of the Unit is to reduce malaria prevalence in Malawi. The principal ways in which the Unit will carry this out are:

- Carefully planned and executed distributions of nets funded by AMF
- Thorough monitoring and evaluation of those distributions
- Detailed follow up to ensure high levels of hang up, by conducting Post Distribution Check-Ups as agreed by AMF, with data gathered on a 6 monthly cycle from randomly selected households.
- Injection Strategy work, to provide nets outside of the normal mass distribution cycles
- Sharing experience and best practice with other agencies in Malawi
- Close working with the NMCP
- Working with Health Centres to ensure reliability of malaria incidence data.
- Other malaria control-related work streams as agreed by AMF and CU.

The Head of the Malaria Unit reports into the Country Head, Malawi, Concern Universal.

Regular reports are provided to AMF, both formally and informally through regular dialogue. Any problems must be raised promptly with both the Country Head and with AMF.
