## Child Care Options in Napa County

Community Resources for Children is the community's link to child care in Napa County; we connect families to appropriate child care and we coach individuals in starting and operating thriving child care businesses.

### Child Care Options for Children Ages 0-5

Community Resources for Children can connect you to licensed child care in Napa County including. Note that the numbers below reflect Licensing ratios during normal times. Due to COVID-19, providers are following guidelines of smaller and stable cohorts:

- **Small Family Child Care Homes** - licensed to care for up to 8 children.
- **Large Family Child Care Homes** - licensed to care for up to 14 children and must have a second caregiver present.
- **Child Care Centers** - licensed to care for groups of more than 12 children.
