NANCY BIRDSALL, FOUNGING PRESIDENT OF THE CENTER FOR GLOBAL DEVELOPMENT, STATED "I THINK CONDITIONAL CASH TRANSFER PROGRAMS ARE AS CLOSE AS YOU CAN COME TO A MAGIC BULLET IN DEVELOPMENT. THEY ARE CREATING AN INCENTIVE FOR FAMILIES TO INVEST IN THEIR OWN CHILDREN'S FUTURES. EVERY DECADE OR SO, WE SEE SOMETHING THAT CAN REALLY MAKE A DIFFERENCE, AND THIS IS ONE OF THOSE THINGS." THROUGH ITS SUBSIDIARY ALL BABIES ARE EQUAL INITIATIVE (ABAE), NEW INCENTIVES OPERATES A CONDITIONAL CASH TRANSFER PROGRAM IN NORTHERN NIGERIA, A REGION WITH ONE OF THE LOWEST IMMUNIZATION RATES WORLDWIDE. THE ORGANIZATION FOCUSES ON KATSINA STATE, ZAMFARA STATE AND JIGAWA STATE WHERE LESS THAN 6% OF INFANTS ARE FULLY VACCINATED (NICS/MICS 2017). MANY PROGRAM RECIPIENTS LIVE BELOW THE POVERTY LINE AND EARN LESS THAN \$1 A DAY. VACCINE PREVENTABLE DISEASES ACCOUNT FOR APPROXIMATELY 22% OF CHILD DEATHS IN NIGERIA. THIS MEANS THAT THE DEATH OF OVER 200,000 NIGERIAN
