Subject: Covid-19 related arrangements at Anganwadi Centres for Pregnant Women& Lactating Mothers and Children, AWWs/AWHs - regarding.

In order to eliminate possibilities of spread of Covid-19 pandemic and for ensuring best possible safety from Covidfor Pregnant Women & Lactating Mothers and Children, Anganwadi Workers and Helpers, ASHA and AXM, being run or supported by this Ministry with the help of State, UT and District Administrations, the following directions are hereby issued with request for ensuring their immediate and compliance:

- i. All <u>physical spaces</u>, <u>furniture</u>, <u>furnishings</u>, <u>equipment</u> etc. in Anganwadi Centres are to <u>be sanitized regularly and on continued basis</u>, with special attention and care towards such portions/ parts/ furniture/ furnishings/ equipment etc. therein which get more frequently physically touched, used or visited. Special care should also be taken for <u>full Covid hygiene</u> in cooking, eating, storage and toilet facilities in such set ups;
 - ii. Hand <u>sanitizers and soaps</u> are to be kept readily available for use by all at such facilities/ institutions/ set ups;

- vi. All provisions as may be available for <u>social security and well-being</u> of beneficiaries and AWWS/AWHs are to be ensured to be made available to them on time. This should include providing of social security <u>pensions</u>, <u>insurance</u> cover etc. as available within the scope of various government schemes and programs.
- 2. It is requested that these directions may kindly be circulated for immediate compliance to all District Collectors/ District Magistrates and other concerned field authorities, (CDPOs and DPOs) for compliance with immediate effect.
- 3. Guidelines issued by Ministry of Home Affairs vide OM No. 40-3/2020-DM-I (A) dated 23rd March, 2021 have also to be adhered to.
- 4. This issues with the approval of Competent Authority in the Ministry of Women and Child Development, Government of India.
