



UPS[®] Peak/Demand Surcharge

October 2, 2022 Update

Effective October 2, 2022 until January 14, 2023, peak/demand surcharges will be applied to Additional Handling, Over Maximum Limits and Large Packages shipments for 19 countries in Europe in order to ensure our network continues to operate effectively during the peak season. Please refer to section D below.

Peak/demand surcharges are subject to change without notice and peak periods may be extended or otherwise changed. Shippers should continue to check ups.com for updates prior to tendering shipments. The surcharges will apply to packages shipped during the specified peak periods for the origins, destinations, and service levels in the amounts set forth below. Peak/demand surcharges apply in addition to all other applicable charges.

A. Peak/Demand Surcharge – Applied to shipments from China Mainland, Hong Kong SAR or Macau SAR to Europe

A peak/demand surcharge applies to any shipment originating from China Mainland, Hong Kong SAR or Macau SAR to 19 countries in Europe¹ for the service levels and peak periods set forth below. Effective August 14, 2022 until further notice, the surcharge amounts applied to these shipments will DECREASE. It will be calculated as a rate per kilogram based upon the billable weight of the shipment.

Peak period (inclusive of starting date) and applicable peak/demand surcharge (rates per kg) for shipments from China Mainland, Hong Kong SAR or Macau SAR

B. Peak/Demand Surcharge – Applied to shipments from other major Asia Pacific origins² to 19 countries in Europe¹

A peak/demand surcharge applies to any shipment originating from other major Asia Pacific origins² to 19 countries in Europe¹ for the service levels and peak periods set forth below. Effective August 14, 2022 until further notice, the surcharge amounts applied to these shipments will DECREASE. It will be calculated as a rate per kilogram based upon the billable weight of the shipment.

C. Peak/Demand Surcharge – Applied to international shipments for 19 countries in Europe¹

A peak/demand surcharge applies to any international shipments originating from 19 countries in Europe¹ to all destinations, as well as any import shipments coming into and invoiced in those 19 countries (e.g. import freight collect shipments, but excluding shipments from, China Mainland, Hong Kong, Macau and the other major Asia Pacific origins outlined above).

Effective September 25, 2022 until further notice, the peak/demand surcharges applied to the Worldwide Expedited, Express and Express Freight Collect shipments from the U.S. to 19 countries in Europe will increase. Please refer to table 5 for details.

D. Peak/Demand Surcharge – Applied to Additional Handling, Over Maximum Limits and Large Packages during peak season 2022-2023

During peak season, a temporary peak/demand surcharge applies to any parcels that meet specifications for the Large Package Surcharge* and Over Maximum Limits Charge** as well as the Additional Handling Charge.***

The countries impacted in this scope are: Germany, the UK, France, Italy, Spain, Belgium, Netherlands, Poland, Austria, Ireland, Luxembourg, Portugal, Finland, Czech Republic, Denmark, Hungary, Norway, Sweden and Switzerland.

Effective from 2 October 2022 until 14 January 2023, the Peak/Demand Surcharge will be a flat fee per parcel in addition to existing rates, surcharges and/or fees.

***Large Package Surcharge Specifications**

A package is considered a "Large Package" when its length plus girth [girth = (2 x width) + (2 x height)] combined exceeds 300cm but does not exceed the maximum UPS size of 400cm. Large Packages are subject to a minimum billable weight of 40kg in addition to the Large Package Surcharge.

**** Over Maximum Limits Charge Specifications**

Packages with an actual weight of more than 70kg, or that exceed 274cm in length, or exceed a total of 400cm in length and girth combined [girth = (2 x width) + (2 x height)], are not accepted for transportation. If found in the UPS small package system, they are subject to an additional charge. Packages exceeding 400cm in length and girth combined are also subject to the Large Package Surcharge.

*****Additional Handling Charge Specifications**

- Any article that is encased in an outside shipping container made of metal or wood
- Any cylindrical item, such as a barrel, drum, pail, or tire, that is not fully encased in a corrugated cardboard shipping container
- Any package with the longest side exceeding 100cm (39.5"), or a second-longest side exceeding 76cm (30")
- Any package with an actual weight greater than 70 pounds (32 kg)
- Each package in a shipment where the average weight per package is greater than 70 pounds (32 kg) and the weight for each package is not specified on the source document or the UPS automated shipping system used.

- UPS also reserves the right to assess the Additional Handling Charge for any package that, in UPS's sole discretion, requires special handling.

In consideration of the additional handling required on our part, and subsequent potential delays in processing these shipments, UPS does not provide a money-back guarantee for them. UPS does, therefore, not refund the shipping charges if shipments requiring additional handling are not delivered by the time normally scheduled for such shipment.
