# California COVID-19 & flu

The California Department of Public Health (CDPH) is happy to announce that both COVID-19 and flu vaccines may be administered concurrently per CDC guidelines and My Turn, an all-in-one application for vaccination clinic management, is available for use in schools to support COVID-19 and flu vaccine clinics.

## Why should schools offer COVID-19 and/or flu vaccines?

- Students can be super-spreaders of diseases like flu and school-located clinics support the Public Health mission of protecting populations from vaccine-preventable disease.
- Clinics offer a safe, centralized location for students to get vaccinated with minimal extra effort from families, resulting in fewer sick days and a safer learning environment.

#### Why should I use My Turn?

- Staff and student families can pre-register and then quickly check in on clinic day.
- QR codes can be added to school e-mails and flyers to allow families to easily find the school's clinic on My Turn and self-register their student in advance.
- Walk-in functionality gives families the flexibility of same-day appointments without preregistration on My Turn.
- Paperless minor consent makes it easier for students to get vaccinated when their parents cannot be at the appointment.

#### How do I use My Turn?

- Schools can choose to onboard onto My Turn via a partnership with a provider already
  enrolled with the California COVID-19 Vaccine Program (myCAvax) or they may selfenroll. For the fastest onboarding process, we recommend partnering with an existing
  myCAvax provider. Another option is to enroll directly in myCAvax, but there are medical
  provider requirements that might be challenging for some school districts, which is why
  partnering with an approved provider or local health department using My Turn might be a
  more efficient option. Visit here for more details.
- If you do have a medical provider program within your school district and wish to enroll in myCAvax, you may very well qualify for up to \$55,000 in grants to help support schoollocated vaccines via the CalVaxGrant program. This opportunity has been extended until October 15, 2021.
