The Freedom of Information Act 2000 requires all public authorities to have a Publication Scheme.

The Publication Scheme is a document that describes the types of information that UK Sports Institute Limited (“UKSI”) routinely publish, where you can find the information and whether we charge for supplying it.

UKSI is committed to routinely publishing a significant amount of information and, where possible, providing quick and easy access to material without any need for a formal written request. We do this by publishing as much information as we can through our website, which is designed to function as the key source of our Publication Scheme.

This scheme lists the different types of information that we routinely make available. The scheme is divided into seven categories which describe the general headings under which information is published; each category is further divided into sub-categories for ease of access.

### **Charging for Information**

UKSI do not charge for information available on our website or for providing paper copies of documents requested through the Freedom of Information Act. However, please note if you request multiple copies of the same document, or different documents, a charge may be made.
