## Napa County Resident Child Care Providers

### You could get a reimbursement for AUTHORIZED CPR, First Aid and Health & Safety training.

- Community Resources for Children could provide partial reimbursement to child care center staff and family child care providers for AUTHORIZED EMSA CPR, First Aid and Health & Safety training. Eligible providers may apply to receive up to \$150 for courses that meet health and safety requirements.
- Training must be completed between July 1<sup>st</sup>, 2020 and June 15<sup>th</sup>, 2021, and all applications must be received by **June 15<sup>th</sup>, 2021** in order to be considered for reimbursement. Funding is limited and therefore available to the first applicants.
